Pension application of Elijah Hendrick (Hendricks) W10104 Transcribed by Will Graves Nancy Hendrick f62VA 3/14/14

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Territory of Missouri Northwest in Circuit County of Pike SS

On this 14th day of August 1821 before me, the subscriber, one of the Judges of the Territory of Missouri for the said Circuit personally appeared Elijah Hendrick age 62 years resident in the County of Pike in this said circuit who being by me first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary war:" that he, the said Elijah Hendrick enlisted for the term of two years on the 7 day of March in the year 1776 in Halifax County in the state of Virginia in the company commanded by Nathaniel Cox of the Regiment commanded by Colonel McClannyhan [Alexander McClanachan] in the line of the State of Virginia on the Continental Establishment; that he continued to serve in the said Corps, or in the service of the United States, and that a little before the time when he was to be discharged from service on the account of that enlistment he again enlisted in Thomas Posey's Company of the Regiment commanded by Colonel Morgan [Daniel Morgan] = for the term of three years and continued in service as above until the said period had expired when he was discharged in Williamsburg in Virginia – that he was in the battle at the Capture of Burgoyne [Second Battle of Saratoga, Bemis Heights, October 7, 1777], at the Battle of Monmouth [June 28, 1778] – he was in the expedition against the Indians under General Sullivan [John Sullivan, Indian campaign June-October, 1779] – and that he was at the Siege of Charleston [Charleston South Carolina fell to the British on May 12, 1780] and that he is in reduced circumstances, and stands in need of the assistance of his country for support, and that he has no other evidence now in his power of his said services.

State of Missouri County of Pike: SS

On this 12th day of November in the year of our Lord 1821 personally appeared in open

Court being the Circuit Court & Court of record within & for the said County of Pike, Elijah Hendrick a resident citizen of said County aged sixty-four years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the provisions made by the Acts of Congress of the United States passed on the 18th of March 1818 and the 1st May 1820, that he the said Elijah Hendrick enlisted & served on the Continental establishment from the 7th March 1776 to the month of July 1781 by virtue of two enlistments, the one for the term of two years & the other for three years to the best of his recollection in the following manner – that is to say – on the 7th March 1776 he enlisted for two years (in the County of Halifax in the State of Virginia) in the Company commanded by Captain Nathaniel Cocke, & went to old Williamsburg, where the said Company joined the 7th Virginia Regiment commanded by Colonel McClenachan [Alexander McClanachan]; that he was at Gwinn's Island [Gwynn Island, July 8-10, 1776] at the driving away Governor Dunmore [John Murray, Lord Dunmore, last Royal Governor of the colony of Virginia]; that he afterwards marched to New Jersey and joined General Washington's Army at BondBrook [Boundbrook]; that he afterwards joined the Company commanded by Captain Thomas Posey in Morgan's Rifle Regiment, under whose command he marched to Canada; was at the taking of General Burgoyne & at the battle of Monmouth, that he was under the command of General Sullivan in his Indian expedition; that on his return he joined the company of Captain William Mosely [William Moseley], in the first Virginia Regiment commanded by Russell [perhaps William Russell] & Ball in General Woodford's [William Woodford's] Brigade marched to Charleston South Carolina & was there taken prisoner – and remained there until the month of July in the year 1781 when he was exchanged & set round to old Jamestown & thence went to old Williamsburg where he was discharged – & that of these facts he has no other evidence in his power at this time than the word of a Continental soldier under the solemnity of an oath. – Sworn to & subscribed in open Court 12th October 1781

State of Missouri County of Pike: SS: And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed – that is to say –

(Schedule) – One cow, one sow, one pot, one kettle, one ax & one hoe; I am by occupation a farmer and have my wife Nancy & one son, Moses, living with me; myself & wife are neither able to manage for ourselves my wife is sixty-two years of age, & we are both infirm & of worn-out constitutions; I son Moses is an ever has been of a weakly habit, entirely unable to render us any assistance.

State of Missouri Pike County: SS

The above named Elijah Hendrick personally appearing before me & being duly sworn saith that he enlisted as a private, that afterwards he served as Corporal, & as Sergeant in which last

capacity he acted when discharged, but the time he served in each, he does not recollect & to the best of his recollection, he served under Gen. Ray sometime in the capacity of quarter master – Sergeant – & further the deponent sayeth not – [no evidence that this document was signed by the veteran]

[p 15: On May 29, 1844 in Pike County Missouri, Nancy Hendrick, 83, filed for a widow's pension under the 1838 act stating that she is the widow of Elijah Hendrick, a revolutionary war pensioner at the rate of \$96 per annum; that she married him in Charlotte County Virginia October 27, 1785; that her maiden name was Nancy Harrison; that they were married by license; that her husband died September 11, 1830 and that she remains his widow. She signed her application with her mark.]

[p 16: On May 15, 1844 in Pike County Missouri, Harrison Hendrick gave testimony that the family record annexed is a true copy of the family record of Elijah Hendrick and Nancy Hendrick; that said record is in the affiant's handwriting; that the copy was made from a record made by his father, Elijah Hendrick.]

[p 4: On January 3, 1853 in Pike County Missouri, Moses Hendricks made application as the administrator of the estate of Nancy Hendricks deceased for the pension due her at the time of her death as a pensioner of the United States; that he makes this application on behalf of himself and Nelley Maiden, Patsy Jones, Wesley Hendricks and Johnson Hendricks, the only surviving children of Nancy Hendricks



[p 5: order entered by the Clerk of the Probate Court of Pike County Missouri that Nancy Hendricks died in said County in 1852 on June the 13th survived only by the children named above.]

[Veteran was pensioned at the rate of \$8 per month commencing August 31st, 1819, for service as a private for 3 years plus in the Virginia Continental line; his widow was pensioned in a like amount.]
