Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina, Johnston County: Court of Pleas and Quarter Sessions August Sessions 1832
On this 27<sup>th</sup> day of August 1832 personally appeared in open Court the Court of Pleas and
Quarter Sessions for Johnston County now sitting Jesse Green a resident of Johnston County and State
of North Carolina aged Sixty-eight years who being first duly sworn according to law doth on his oath,
make the following declaration, in order to obtain the benefit of the act of Congress passed June the 7<sup>th</sup>
1832.

That he entered the service under the following named officers and served as herein stated. First I was third division of Johnston County militia State of North Carolina – about the year 1781. I volunteered under the command of Captain Needham Whitfield for the term of six months, was mustered at Johnston County Court House, thence marched to Hillsboro & was there put under the command of Colonel John Herritage, thence to Lewisburg, thence to Tarborough [Tarboro], thence through the Country to Kingston-[sic Kinston] by Cross Creek, thence to Elizabethton took 26 prisoners there sent them to Colonel John Herritage who had them exchanged, thence across the Country to Kinston, thence up to Johnston Court house and was there discharged – my discharge was signed by Colonel John Herritage and Captain Needham Whitfield, but I have lost or mislaid the same. I have no documentary evidence – I can prove this service by my fellow soldier Amos Atkinson<sup>2</sup> – Served the whole period of six months.

Second I moved shortly after my return to Edgecombe County State of North Carolina, I was then and there drafted for three<sup>3</sup> months in said County under the command of Captain Theophilus Thomas, was marched by him to Halifax joined other companies there and was placed under the command of Colonel Jonas Johnston, we were there joined by 22<sup>nd</sup> and 23<sup>rd</sup> Regiment of Continentals under the command of Colonel \_\_ and Captain John McCoats [?]<sup>4</sup> and Captain Benjamin Coleman commanded companies belonging to said regiments and Lieutenant Thomas Gibson was also there. He remained there some time, marched to Tarborough – thence to New Bern thence to Wilmington, which place we went to take by storm, but the British evacuated the town, thence to Kinston was there discharged – have lost or mislaid the same. I have no documentary evidence of this service. I know of no person that can prove this service – shortly after this I learned of the Capture of Lord Cornwallis [Battle of Yorktown, October 19, 1781].

I hereby relinquish every claim to a pension or annuity except the present and I declare that my



I Amos Atkinson do hereby certify that I am well acquainted with Jesse Greene believe him to be sixty-eight years of age, I served six months with him under Captain Needham Whitfield, and marched with him as mentioned in the first part of this declaration.

[p 12: On February 17, 1853 in Franklin County North Carolina, Mary Green, whose maiden name was Mary Price, aged 55 years made application for a widow's pension under the 1853 act; she states she is the widow of Jesse Green who was a revolutionary war pensioner at the rate of \$30 per annum; that she was lawfully married to him in Johnston County North Carolina in the month of December 1823 by old William Wall, a minister of the gospel; that her husband departed this life on Wednesday the 9<sup>th</sup> day of February 1853 and that she is now a widow. She signed this document with her mark. In this document, the widow of alleges that her husband's pension was suspended in 1843 as he was informed by letter from the War Department for having signed documents containing false statements as to his service; that her husband's application was prepared by John Gully a man of infamous character who had substituted an application different from that read to her husband; that their daughter Martha Green was present and saw Gully make the substitution and knows well that her husband never intentionally made any false statement regarding his services.]

[p 7: Mary Green, near 55 years of age, filed in Johnston County, NC on November 27, 1855, for her bounty land entitlement as the widow of Jesse Green who she states was a revolutionary war pensioner at the rate of \$30 per annum; that she married him in Johnston County in 1830; that her name before her marriage was Mary Price; and that her husband died in Franklin County North Carolina on February 9, 1853. She signed this document with her mark. Her application was supported by the affidavits of William H Price and Martha Green whose relationship to the widow is not stated.]

[p 36: On May 9<sup>th</sup>, 1868 in Wilson County North Carolina, the widow, aged about 65 years, describing herself as a resident of Green County North Carolina made application for the restoration of her pension benefit following the Civil War.]

[Facts in file: Jesse and Mary had a daughter named Martha A. who was 20 years old in 1853; in 1868, Mary was living in Greene County, NC and states that since 1861 she had lived in Nash, Wilson and Greene Counties, NC with her children (not named); Mary died November 13, 1878. The documents in this file do not contained an explanation of the discrepancy regarding the year in which the veterans marriage to Mary Price took place.]

[Veteran was pensioned at the rate of \$30 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 9 months in the North Carolina militia.]
