Pension application of Joseph Reed [Reid, Read] W1484 Elizabeth Reed f43SC Transcribed by Will Graves 11/23/09: rev'd 1/1/18

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Knoxville of September 29th 1828

To the Honorable the Secretary of War Washington City

Your petitioner respectfully represents to your Honor that on the 11th day of June 1823 he was placed on the pension roll of East Tennessee as an invalid pensioner of the United States at the rate of \$5.33 1/3 cents per month. Your petitioner represents that the pension heretofore allowed is insufficient to afford him a comfortable maintenance that he is now in the decline of life and has advanced to the age of 78 years. That the aggregate amount of his property is not worth \$25 at most; that he is in a helpless and dependent condition and for the few remaining days of his life he is necessarily forced to rely upon the charity of his country for a support; Your petitioner labors under a total disability in consequence of his wounds and his advanced age to perform manual labor of any kind whatever. So great is his disability that he is unable even to walk without the assistance of 2 crutches. According to the existing rules and regulations of the war department he has biannually to undergo an examination of 2 physicians who state the degree of disability under which he labors. This regulation has hitherto subjected your petitioner to great trouble and inconvenience his disability for several years past being so great as almost totally to preclude the possibility of going to a place where such an examination could be made conveniently made. It is known to your honor that the charges of professional man for the said services are considerable and if he was driven to the necessity of employing persons to come and examine him at his place of residence the fees would very nearly if not quite cover the paltry sum to which your petitioner is at present entitled.

He would respectfully submit to your honor whether under the extreme disability he labors a compliance with such a regulation would be expected.

Your petitioner humbly requests that he may be placed on the roll of "total disability" and be entitled to full pay. The wounds above alluded to our wounds that were received by your petitioner in the revolutionary war while in the service of the United States

Increase of pension

It is hereby certified that Joseph Reed formerly a volunteer of Captain Joel Lewis company in Colonel Cleveland's [Benjamin Cleveland's] Regiment of __ who it appears by the accompanying certificate was placed on the pension roll at the rate of five 33/100 dollars per month on account as he states of having received a gunshot wound in the left thigh which appears to have fractured the femur in the thigh is three or four inches shorter than the other and that his disability continues to increase while in the line of his duty and in said service on the 7th day of October in the year 1780 at a place called Kings Mountain in the State of North Carolina is not only still disabled in consequence of said entry but in our opinion is entitled to one 3rd more than he already receives as a pensioner being disabled a degree amounting to a total disability.

[p 12: On June 17 1839 in Campbell County Tennessee, Elizabeth Reed, "whose maiden name was fiels [sic, Fields?] a resident of said County aged 80 years March the 10th from the best of her recollection" made application for a widow's pension under the 1838 act stating that she is the widow of Joseph Reed who was a pensioner of the United States at the rate of \$96 per annum; that she married her husband in Edgefield South Carolina on October 15 1783; that they were married by Benjamin Tut [sic, Benjamin Tutt], a justice of the peace; that her husband Joseph Reed died in Campbell County Tennessee September 6, 1830; and that she remains his widow. She signed her application with her mark.]

[p 14: In August of 1839, in Morgan County Tennessee, Nancy Reed, widow of John Reed, a pensioner of the United States for his services in the revolution and the brother of Joseph Reed gave an affidavit in support of the claim for a pension made by Elizabeth Reed. She signed her affidavit with her mark.]

[p 16: John Reed testified on June 17, 1839 in Campbell County Tennessee that he had often heard his father, Joseph Reed, state that he and Elizabeth were married by justice Benjamin Tutt.

[p 17: Rhoda Roach gave testimony in Campbell County Tennessee on June 17, 1839 in support of her mother's application for a pension. She signed her affidavit with her mark.]

To the Honorable the president and Members of the Honorable the Senate The Petition of Joseph Reed Humbly Sheweth.

That your Petitioner was a resident of this State before the 1st January 1775 and after the fall of Charleston [Charleston South Carolina fell to the British on May 12, 1780] he became a Refugee with Colonel Benjamin Cleveland under whom he fought at the battle of Kings Mountain and was there Wounded by having his thigh broke ye 7th of October 1780. And from thence he was conveyed with the Wounded to the Quaker Meadows and lay there under the Doctor upwards of twelve months. Under which circumstance your Petitioner suffered, not being able to draw any support from the public until the year 178?[paper damaged and last digit missing].

Your Petitioner therefore humbly begs leave to lay his Case before your Honorable house, hoping that you will Allow him his Annuity from the time of his being Wounded to the year 1776. Or Grant him such other relief as you in your Wisdom shall seem right and your Petitioner as in Duty bound Will Ever pray &c.
