[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.1

State of Tennessee Wilson County

On this day being the 4th day of April 1839 personally appeared before me Silas Tarver – an acting Justice of the Peace for the County of Wilson duly commissioned and qualified to hold the County Court of Wilson in the said State of Tennessee Sarah Chandler a resident of the County of Wilson aged seventy-five years having been born on the 24th day of August 1762 in the County of Culpepper [sic, Culpeper] Virginia according to the family Register – who being duly sworn according to law doth on her oath make the following Declaration in order to obtain the benefit of the provision made by the Act of Congress passed July 7th 1838 Entitled "An act granting half pay and pensions to certain Widows:" That she is the widow of Josiah Chandler who was born in Henry County Virginia on the 12th day of July 1762 the said Josiah Chandler her husband was a soldier of the Revolution he entered the Revolutionary Service in the year 1778 or 1779 as well as she is able to ascertain at this distant day in the company commanded by Captain William Lenoir of Wilkes County North Carolina to which County her said husband had moved with his Father and was attached to the Regiment commanded by Colonel Cleaveland [sic, Benjamin Cleveland] of the North Carolina line [sic, militia] he was a volunteer and was in active service for ten months he was at the Battle of Ramsour's Mills and the Battle of Kings Mountain – he also served a sixty days tour under the command of Captain John Kees against the Indians in the year 1782 as will appear by a paper writing found amongst the papers of her said husband his discharge has been lost or mislaid – Declarant does not know that she can prove the services of her husband by any other persons then by the testimony of William Eddings¹ and Rebecca Eddings. She further declares that she was married to the said Josiah Chandler on the 26 day of August 1784 and that her husband the aforesaid Josiah Chandler died on the 22 of October 1827 in the County of Wilson where he resided that she was not married to him prior to his leaving the service but the marriage took place previous to the first of January 1794 that he is to say at the time above stated.

This day personally appeared before me Silas Tarver an acting Justice of the Peace for the County of Wilson aforesaid William Edings a resident of the County of Wilson aged eighty-one years who being first duly sworn according to law says that he was well acquainted with Josiah Chandler the husband of the said Sarah Chandler that he was present when the said Josiah and

Sarah his wife were married and that their marriage took place as well as he remembers in the year 1784 – Deponent was acquainted with said Chandler from his boyhood up to the time of his death. Deponent was a soldier of the Revolution and is now drawing a pension – he knows that said Josiah Chandler was a soldier of the revolution deponent was in this service with him – as well as he remembers said Chandler was in the Company commanded by Captain Lenoir and in the Regiment commanded by Colonel Cleveland. Deponent has often heard him say that he the said Chandler was at the Battles of Ramsour's Mills and the Kings Mountain and he has no doubt that said statement was true. Affiant can with great certainty say from his knowledge of the services of the said Chandler he served ten months in the Revolutionary War. Sworn to and subscribed the fourth of April 1838 before me

State of Tennessee Wilson County: This day personally appeared before me Silas Tarver an acting Justice of the Peace for the court of Wilson and State of Tennessee Rebecca Eddings and made oath that she was well acquainted with Josiah Chandler Deceased – that he was her brother they lived in the same house together she knows that he was a soldier of the Revolution and was on several tours of duty and from her best recollection she thinks he served 10 or 12 months – she was also present at the marriage of the said Josiah and Sarah Chandler and it took place at the time mentioned in the Declaration of the said Sarah said Sarah Chandler is the widow of the said Josiah and she has never been married since his death.

State of Tennessee Wilson County: This day being the 2 day of September 1839 personally appeared in open Court before the said Justices holding the Court for the County Court of Wilson at their September term 1839 William Eddings aged 82 years and made oath that he was well acquainted with Josiah Chandler the husband of the said Sally who now petitions for a pension – he was a soldier of the Revolution in the North Carolina line and served ten months one tour of six and another of four months and served under Captains Keys and Lenoir and in the Regiment commanded by Colonel Cleveland and the Regiment was commanded a part of the time by Colonel Lenoir affiant knows that said Sally Chandler and the said Josiah Chandler were married on the 26th of August 1784 – Affiant was at their wedding and has known his friend [?] as well before as ever since, he believes the Register of the birth marriage etc. of the said Josiah Chandler and the said Sally here exhibited is correct and is also all of whom he has known. Affiant was himself a soldier of the Revolution and is now drawing a Pension. Sworn to & subscribed in open Court

[p 27: on June 18, 1846, in Wilson County Tennessee, Mrs. Sarah Chandler, 84, filed for a widow's pension under the 1843 act stating that she is the widow of Josiah Chandler.]²

[Veteran's widow was pensioned at the rate of \$20 per annum commencing March 4th, 1843 for the service of her husband as a private in the North Carolina militia.]

² It is not clear to me from the documents in this file by the widow had to apply the second time for her pension or why the pension evidently was not granted until this petition.
