Pension application of Henry (Patrick Henry) Roberts¹ W164 Catharine f82PA [VA/MD]
Transcribed by Will Graves 7/9/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Kentucky Franklin Circuit Court Sct. July Term 1830

Henry Roberts this day produced in Open Court & made oath to the following declaration (viz.) "State of Kentucky Franklin County SS. Henry Roberts made the following declaration in order to be placed on the pension list under the act of Congress of 18th of March 1818 on the 19th day of July personally appeared in open Court it being a Court of record for the Circuit of Franklin County aforesaid, Henry Roberts a resident of Franklin County aforesaid aged seventytwo years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the act of Congress of the 18th of March 1818 and the 1st day of May 1820. That he the said Henry Roberts enlisted for the Term of three years on the 1st day of September in the year 1777 in the State of Virginia on Continental establishment in the 3rd Regiment of Light Dragoons then commanded by Colonel George Baylor (after Colonel Baylor was taken Prisoner by the British in October 1778 that Regiment was commanded by Colonel William Washington). That he was mustered in and served in the 4th Troop of that Regiment which Troop was commanded by Captain Cadwallander Jones [Cadwallader Jones] the Lieutenant's name was John Stith, the Cornet's name was Cheswell Barrett [Chiswell Barrett or Chisholm Barrett ?] after the defeat of that Regiment in October 1778 at Tappanm [Battle of Tappan or Baylor massacre" September 27, 1778] in the State of New Jersey at which John Swan Captain of the 5th Troop was also taken prisoner then John Stith one Lieutenant took command of the 5th Troop of that Regiment. That he served in said Regiment until the Term of his enlistment had expired when he obtained his discharge from said Regiment. That he also served in the Maryland line on Continental establishment in the year 1776 and was regularly discharged at the expiration of the time of his enlistment in that line in December 1776 by Captain Frederick Tams [?], that his name is not on the muster Rolls of any State except in the Maryland in 1776 and then in the Virginia line in the above named 3rd Regiment & 4th Troop & lastly in the Pennsylvania Militia in the winter & fall of the year 1781. That he applied to the Secretary of War in April 1827 to be placed on the pension list and received no answer that I have two [too] much property and the reason he had not applied sooner was that the assessors of property in Kentucky estimated its value in Commonwealth Bank paper which paper had from 1820 to 1824 depreciated so that \$2 thereof, was only worth \$1 in specie so that by this mode of assessment his property appeared to be worth too much and in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to

diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed (the necessary clothing & bedding excepted)

[f p. 11: On March 8, 1853, in Franklin County Kentucky, Catharine Roberts, 63, filed for the arrears, increases, or allow also pay, half pay or pension money due her as the widow of Henry Roberts deceased who died May 23, 1839 and who at the time of his death was a pensioner of the United States at the rate of \$96 per annum under the 1832 act; that she drew the arrearages due him after his death; that she was married in the city of Baltimore Maryland June 20, 1810 by Lewis Richards a Baptist preacher; that her name before her marriage was Catharine Austin. She signed her application with her mark.]

These are to Certify to whom it may concern that on the 20th day of June in the Year of our Lord 1810, the Rites of Marriage were Solemnized according to Law, between Henry Roberts and Catharine Austin by me.

[Veteran was pensioned at the rate of \$8 per month commencing January 8th, 1831, for service as a private for 3 years in the Virginia Continental line. His widow was pensioned in a like amount. Her pension was increased to \$100 per annum commencing February 3rd, 1853.]

C. Leon Harris adds the following notes:

NOTES:

In the file of John Casey (pension application S30308) is a letter dated 17 July 1823 in which Roberts described as follows the march northward after enlisting in the 3rd Regiment of Light Dragoons: "Sometime in the month of October in the year 1777 he the said John Casey joined the 4th Troop at Fridricksburgh [sic: Fredericksburg] in Virginia together with a man by the name of Bowmer, which 4th Troops of s'd. Reg't. was then to be made up of the new recruits. About the first of Nov'r. in the same year orders were rec'd. at that place to march the s'd. Troop to the Northward to join the reg't. somewhere near the Valey where head quarters then was. Some few days thereafter the said Troop started from Fredricksburgh V. under Capt Cadwalowder Jones, Stith, [William] Parsons, John Bailor [sic: John Baylor] & Chis'l Barrett. On the 3d day we arived in the neighbourhood of Alexandria, it was reported there that the small pox raged at that time in that City and in George Town. There being many new recrutes in said Troop who had not had the small pox the officers did not march the men through either of those Towns and concluded to halt the men by the road until a boat could be procured on the river above George Town where they might pass the river in safty. In consequence the men were encamped about 2 miles west of the Patomac [sic: Potomac] river in a small field on the left hand

as we went eastward, where it was intended they should remain that night." On 8 March 1853 Catherine Roberts, 63, applied for any arrears or increase in the pension of her husband, Henry Roberts, stating that in his youth he was called Patrick Henry Roberts, that her maiden name was Catherine Austin, that they were married in Baltimore by a Baptist preacher named Lewis Richards on 20 June 1810, and that Henry Roberts died 23 May 1839. The file includes the original license and certificate of the marriage of Henry Roberts and Catharine Austin. Their son, Edmund A. W. Roberts, 30, certified the authenticity of the marriage certificate. On 30 April 1855 she applied for bounty land.
