Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of North Carolina, Johnston County

On this 17<sup>th</sup> of April 1843 personally appeared before the Subscriber One of the Justices of the Peace in and for said County Mary Gerldin Resident of Johnston County aged 88 years who being first duly sworn according to law doth upon her Oath make the following declaration in order to obtain the benefit of the provisions made by the Act of Congress passed the 4<sup>th</sup> July 1836 that She is the Widow of Isaac Gerldin who was a Continental Soldier of the Army during the Revolutionary War that he enlisted for three years in the year 1776; in the latter part of the year she believes he left home he served the whole tour of his Enlistment under what officers this declarant is unable to say at this time but she has frequently heard him speak of having served in Colonel Martin's [Alexander Martin's] Regiment and his discharge which he Once had but being considered of no value has long since been lost, She has frequently heard him say was given him by Colonel Alexander Martin of his service though, this declarant only swears to what was often times repeated to her by her late husband Isaac Geldin She can speak particularly of the length of time he was absent from home which she knows about three years she further declares that she was legally married to her late husband Isaac Geldin in the County of Johnston State of North Carolina in the month of October 1775 by Everet Pearce a Justice of the peace that her maiden name was Mary Bailey [sic] that she was married at the house of her father William Baley [sic] who resided on Contentnea Creek in Johnston County a few miles from where this declarant now lives that there were several persons present at her marriage and of whom she believes are now living that she has no record of her marriage nor does she believe any was made if it was she cannot now find it she has no Registration of the ages of her Children her husband being an Illiterate and Ignorant man she does not believe any Record of their ages was made by him She has now living four Children the Older Laury Saper [?] is now in the 67<sup>th</sup> year of her age that she was born in a few months before her father Isaac Gelden left home to enter the Service in the Revolutionary War this event the more strongly impresses the time of the birth of her daughter on her memory Especially as she was left alone with her Child and Experienced a Great many hardships during his long absence that her husband the aforesaid Isaac Geldin died in Johnston County on the 10<sup>th</sup> day of March 1832 aged as she always understood 78 years all which will more fully appear by reference to the Proof hereunto annexed that she has been but recently made acquainted with her Right to a pension on account of the Services of her husband which she finds she is Justly entitled to.

On this 18<sup>th</sup> day of April 1843 personally appeared before me John Pearce aged 87 years and

Arnold Baley aged 80 years Residents of said County who having been first duly sworn according to law doth on their oath make the following affidavits.

These affiants Testifies that they are well acquainted with Isaac Geldin deceased a Soldier of the Revolutionary War, that he Resided in Johnston County, of his marriage with Mrs. Mary Geldin his widow now applying for a pension we are well acquainted with them and know they were married, we were both at the Wedding at the house of William Baley Father of Mrs. Mary Geldin and Uncle to one of these affiants, Arnold Baley, they were married about or just before the Commencement of the Revolutionary War, they were married on Contentnea Creek in Johnston County by Everet Pearce Esquire we think Mrs. Mary Geldin had her oldest Child about the first of the year 1776 which was Mrs. Laney Saper now wife of John Saper of Johnston County they lived together as man and wife as long as he lived since his death which was about 1832 Mrs. Geldin has remained a Widow and always sustained a Good Character as a prudent & Industrious lady Isaac Geldin was always reputed to be a Soldier of the Revolutionary War in his neighborhood we have often heard him speak of Events which took place.

Given under our hands this 18<sup>th</sup> April 1843

[p 9: On April 18, 1843 in Johnston County North Carolina Enos Geldin gave testimony that he was well acquainted with his father Isaac Geldin; that he is the next child to Laney Saper, his sister, and has always understood that his sister was born about the time of the Revolutionary War; that he calls himself 60 years of age having understood that there were about 7 years between his birth and that of his sister.
