[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Virginia Spotsylvania County: SS

On this the 5th day of December 1837 personally appeared before me a justice of the peace in and for the County aforesaid Sarah Willoughby a resident of the County and State aforesaid aged 78 years who first being duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July the 4th 1836 that she is the widow of William Willoughby who was she believes a Sergeant in the Army of the United States in the war of the revolution she does not recollect if she ever knew where he served but believes it was to the North before her marriage nor does she recollect what officers he was under she can only say that he enlisted after having served as she believes an enlistment of four years was discharged immediately after which she was married to him the said William Willoughby in the County of Spotsylvania by Parson Stephenson on the 30th day of June 1779 that after their marriage he was in the service at different times she thinks to the end of the war but cannot recollect how long she recollects he went to the Town of York and there served under whom she cannot say she is enabled to speak definitely as to the marriage from the family register as also of his death which took place on the 29th of October 1815 that she has remained his widow ever since that period as will more fully appear by reference to the proof hereto annexed.

Caroline County State of Virginia SS

On this the 7th day of December 1837 personally appeared before me a Justice of the Peace in and for the County aforesaid, John Oliver, of said County who, after being sworn according to law made the following declaration, that he was in the War of the Revolution, that he entered the service under Captain John Fitzick [John Fitzhugh?] and attached to Colonel Samuel Temple's Regiment and served out his two years principally as a guard up and down the River but, he thinks, the same year he was discharged he entered the service again by draft and went under Captain David Janssen and went again to Williamsburg and was under Major Armistead & Colonel Mathews till discharged in 1781 he was again drafted before the siege of

York Town and was under Captain John Fitzick but in Gloucester County nearly opposite Yorktown he joined Captain Seizor or some such name, who was attached to General Weedon's Brigade where he served his time out in which expired after the siege of York Town, he further says that he knew William Willoughby well, that said Willoughby served, he believes, verily the whole war, part of the time in the Continental line & part of it in the Militia, that he was at the siege of York and he believes, did serve to the end of the tour, but of this fact, will not be positive. I do furthermore certify, that John Oliver is a man of the highest respectability in point of moral worth and that from a long life spent in this County, I feel assured, he has the confidence of all who know him, as a man of the strictest veracity, that he is now a Pensioner. I John Pierce <sup>2</sup> of the County of Spotsylvania and State of Virginia do hereby certify I served several tours of duty as a militia man in the war of the Revolution and am now receiving a pension that I entered the service as early as 1775 and served at different times the last tour I served having been finished a few days previous to the siege of York Town in October 1781. I also certify that I was acquainted with William Willoughby late of this County who married Sarah Sorrell sometime in the summer of 1779 that after their marriage said Willoughby was in actual service in the Army of the United States but for what length of time I cannot speak positively. I also certify that said Sarah is now and has remained the widow of said weeding Willoughby. Given under my hand this 10th day of February 1838



[p 11: On November 17, 1850 in Spotsylvania County Virginia, Elizabeth Gibson filed a claim in which she states she is the daughter of Sarah Willoughby, widow of William Willoughby deceased; that Sarah Willoughby departed this life the 17th day of February 1849; that Sarah Willoughby was a pensioner under the act of 1838 as the widow of William Willoughby; that her mother received a pension as the widow of a private when in fact she was entitled to a pension as the widow of a Sergeant; she files this claim on behalf of herself and her sister Lucinda McCloud

the only surviving children of the said Sarah Willoughby.

State of Virginia Spotsylvania County: to wit

I do hereby certify that I was a Revolutionary pensioner of the United States; and that I know of my personal knowledge that my brother William Willoughby deceased, whose widow now allowed a pension under the act of Congress of July the 7th 1837, was a Sergeant in the Revolutionary war for more than 2 years in Captain Joseph Spencer's company of Infantry in the Virginia line on Continental establishment. Given under my hand this 28th day of October 1851 S/ Henry Willoughby, X his mark

Memorandum: This affiant does not mean to say that William Willoughby served the whole time in Captain Spencer's Company, but that he entered the service under his command and served in fact five years a part of which time he was a prisoner.

[Veteran's widow was pensioned at the rate of \$80 per annum commencing March 4th, 1831, for her husband's service of 2 years and upwards as a private in the Virginia Continental line.]

These may certify that Wm Willoughby formerly a Soldier in the fifth Va Regt. hath duly and faithfully serv'd out the Term of three years for which he was enlisted in consequence of which and at his own Request he is hereby discharg'd from any further Service in s'd Regt he having receiv'd all his Bounty pay and Cloathing in full for all allowanc and Provision made by Congress for their Troops.

### State of Kentucky Fayette County Sct

Frederick Coons [S35844] being duly sworn, saith that he knew William Willoughby as Sergeant in the state of virginia and that he knew him said Willoughby in the revolutionary war and that he served in the Virginia line on Continental establishment in the 7<sup>th</sup> Regiment and in the company of Capt Joseph Spencer. that he knew him in the year 1777 1778 & 1779 and that he inlisted during the war and was honorably discharged at the expiration of the Service

On motion of Anthony Arnold it was proven to the satisfaction of the Court that William Willoughby was a soldier of the Virginia Continental Army in the Revolutionary War and that he is now dead, and that Nancy Arnold, late Nancy Willoughby, Betsy Gibson late Betsy Willoughby William Willoughby Lucinda McCloud late Lucinda Willoughby and Sidney Martin late Sidney Willoughby are the only heirs at law of said William Willoughby deceased. It is ordered that the same be Certified to all whom it may concern.

### State of Kentucky Fayette County Sct.

John Nelson [S35537] late a Lieutenant in the 7<sup>th</sup> Virginia Regiment on Continental line during the Revolution and now Receiving the benefits of the late Act of Congress, made Oath before me a Justice of the Peace for said County that he was personally acquainted with William Willoughby previous to the Revolutionary War, and that he knew said Willoughby as a Sergeant in Capt. Joseph Spencers Company in said Regiment for Five years, when this Affiant was ordered to the South leaving said Willoughby in the Service and saw him nomore during the war, and when this deponent returned to Spottsylvania Virginia in the year 1783 he saw said Willoughby and heard and always understood and believes that said Willoughby served during the war.

Sworn to and subscribed before me and I certify that Capt. John Nelson is on the Pension Roll & highly credible on Oath this 5<sup>th</sup> day of Aug't 1830.
