Pension Application of Adam Bosteyon (Boston) W18622 Juliet or Julianna Boston VA Transcribed and annotated by C. Leon Harris. Revised 1 Oct 2018.

For the purpose of obtaining the benefits of the act, entitled "An act for the relief of certain surviving Officers and Soldiers of the Army of the Revolution," approved on the 15th of May, 1828, I, Adam Bosteyan of [blank] in the county of Frederick in the State of Virginia do hereby declare, that I enlisted in the Continental Line of the Army of the Revolution, for and during the war, and continued in its service until its termination; at which period, I was a private in Captain Armongs Troop [sic: Col. Charles Armand's Partisan Corps], Colo [Charles] Dabney Regiment, of the Virginia Line. And, I also declare, that I afterwards received certificates for the reward of eighty dollars; to which I was entitled, under a resolve of Congress, passed the 15th of May, 1778.

And I further declare, that I was not, on the fifteenth day of May, 1828, on the Pension List of the United States.

Personally appeared before me Thomas F. Nelson a Justice of the Peace in and for the county aforesaid, the second day of February in the year 1841 Juliet Boston a resident of the said county, aged seventy seven years, who being first duly sworn according to law, doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed the [blank] day of [blank] in the year one thousand eight hundred and thirty [blank], that she is the widow of Adam Boston who was a soldier of cavalry of Captain Tinsleys [Samuel Tinsley, pension application S6243] company of Cavalry of the Corps commanded by Major John Nelson [W5414] of the virginia troops of the army of the Revolution enlisted for the period of the war, and that as she has always understood faithfully served to the end of it. She is unable at this time to state the several battles in which he fought, except that he was at the seige of york in virginia [28 Sep - 19 Oct 1781], or the country through which he marched, nor has she any documentary evidence in her possession in support of her claim other than such as has been recently obtained from the offices in Richmond Virginia. That he departed this life in the county of Frederick, now Clarke, on the 5th day of March 1832. She further declares that he maiden name was Juliet How[?]. that she married the said Adam Boston on the [blank] day of [blank] in the year 1785 in the county of Berklay [sic: Berkeley] and state of Virginia by [blank] but that she has been unable to obtain any documentary evidence of her said marriage, and that she is at this time a widow, and has not again married since the death of the said Adam Boston.

Also at the same time personally appeared before me Thomas F. Nelson, justice of the peace as aforesaid Philip Burwell & Philip Nelson who I do hereby certify to be witnesses of credibility, who are aged persons, who being also sworn according to law, do say that they have long been personally acquainted with Juliet Boston who made the foregoing declaration, and also with her late Husband Adam Boston, and that they feel most confident that she is the identical person who she represents herself to be, and that her Husband was a soldier as above stated in the war of the Revolution, and that she is now at this time a widow, not having been married since the death of the said Adam Boston.

Also at the same time appeared before me Robert H. Little who being duly sworn doth say that he has long been the family Physician of the said Adam Boston during his life, and of his widow Juliet Boston since his death, that he does not believe that the said Juliet Boston can with safety and convenience on acc't. of her age and bodily infirmities attend the Courts of Clarke county in order to make her foregoing declaration in the Court. Longbranch 30th March 1841 Dear Tom

I have been reflecting a good Deal on the subject of Mrs Bosteyans claim since you left me. I would advise you to enquire of Philip Foaste[?] at the town Mill as of the old Lady to know how many children she brought when they came from Helms's old Mill to Major Massie I think I recollect perfectly Major Massies waggon bringing Bosteyons family to his mill when I lived in Millwood & I think they had 1 or 2 children or perhaps more with them in seventeen hundred & ninety four I mov'd from Millwood on the 1st of Jany [year lined out but may be 1794], So I think that it must have been in 1793 when I saw them coming to Major Massies Mill. Perhaps Sam'l Briarly can tell for he was a man grown & probably more in Bostevans line of life than I was. I am your Affe'tly/ Philip Nelson

John Baker the brother of Henry Baker

The deponent John Kerfoot saith that so early as the year 1791 he knew Adam Boston who was then living at a mill owned by one William Helm in the county of Frederick & state of Va. that the said Adam Boston removed from said Mill as early as the year 1793 to a mill situate in what is now Clarke county state of Va. said latter Mill having been built being owned by Major Thomas Massie formerly of the county of Frederick & State of Va.
