

State of North Carolina Robeson County: In pursuance of the annexed commission from the Court of Pleas and Quarter Sessions held for said County and State I James D Bridgers attended at the House of Mrs. Sarah Bullard of said County who made the following Declaration to entitle her to a pension in right of her deceased husband James Bullard for revolutionary Services under the Acts of Congress passed for that purpose. She the said Sarah Bullard being now from eighty to ninety years of age. That her husband entered the service of the United States of America about the year 1777 under Captain John Cade and served __months. That he again entered the service of the United States under Captain Robeson or Ervin and served several months. That he again entered the service of the United States and served a number of months under different officers. That he again entered said service and served __ months under. That he performed other services in the United States Army which this Declarant has now forgotten by reason of her advanced age and consequent loss of memory. That he served in the Army in the States of North & South Carolina and Georgia under the following officers namely General Green [sic, Nathanael Greene], Colonel Brown, Captain McKissick, Captain McRee and others not recollected. That he was in the Battles of the Slipery Bridge [sic, Slippery Bridge] & others the names of the places not recollected. This Declarant further states that she intermarried with the said James Bullard in the month of December 1774 that the said James Bullard departed this life in the month of April 1832.

The said Declarant further exhibits the annexed furlough signed by Colonel Thomas Brown and the annexed discharge signed by Captain Turpin McRee in support of her claim & swears that she found them among the papers of her deceased husband James Bullard.

[fn p 18: on January 11, 1853, John McLean, 80, a resident of Robeson County gave testimony that he was well acquainted with James Bullard before and after his marriage; that he recalls that James and Sarah Bullard were married in Bladen County (now Robeson County); the fact of their marriage is impressed on his mind by the circumstance that a brother of James Bullard named John was married at the same time; that James and Sarah Bullard lived together as man and wife after their marriage and that the legality of their marriage has never been questioned.]

[fn p. 7: Power of attorney dated July nine, 1851 executed by Robert Bullard and Elias Bullard in Robeson County North Carolina whereby they in power their attorney to prosecute the claim of Sarah Bullard for a revolutionary pension. , On the same day they executed an affidavit in said County of Robeson stating that they are the children of Sarah Bullard widow of James Bullard a revolutionary soldier. In another document, the court found that Sarah Bullard died June 27, 1843 leaving surviving her the following heirs: Sarah Pitman, wife of Jacob Pitman, Robert Bullard, James Bullard, Elias Bullard, Richard Bullard, Priscilla Jackson, wife of Henry Jackson; and that both Sarah Pitman and Priscilla Jackson have since died.]

[NOTE: there are two letters in this file, one dated Augt 10, 1833 and the other dated December 14, 1833 in which reference is made to an application made by John Bullard, but no such application is to be found in this file—I assume that these two letters were mistakenly filed in the wrong file as this veteran's name was James Bullard and as he died, according to his wife, in April 1832, before the passage of the June7, 1832 pension act.]

[Veteran's widow was pensioned at the rate of \$63.33 per annum commencing March 4th, 1831, and ending June 27, 1843 under the 1832 act for the service of her husband as a private in the revolution; she was pensioned in her own right under the 1836 act.]
