Pension application of Joseph Payne W18693 Ann f68VA Transcribed by Will Graves 9/26/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." At a court held for Bath County on the 12th day of May 1818 Joseph Payne came into court and being sworn deposeth and saith that he enlisted in the Service of the United States during the Revolutionary War under Captain Samuel Woodson of the 9th Virginia Regiment in the latter part of the winter 1775 or early in the spring of the year 1776 as a Sergeant, and served in that capacity until the spring of the year 1777 when he was commissioned as an Ensign and attached to Captain Smith Snead's Company in said Regiment where he continued until the 4th of October 1777 at which time he was captured by the British together with the Regiment and was retained in captivity until the latter part of the winter 1780 and was then discharged early in the spring 1781, he attended a meeting of Officers of the Virginia line at Chesterfield Court House at which time he resigned in consequence of being afflicted with a cough under which he has labored ever since and he now remains due circumstances in life.

At a Court held for Bath County that the Court House on the 8th day of August 1820

This day Joseph Payne personally appeared in open Court being a court of record for this County aged sixty-one years who being duly sworn according to law doth on his oath declare that he served in the revolutionary War as follows he enlisted for the term of two years in the Spring of the year 1776 in this State in the Company commanded by Captain Samuel Woodson in the Regiment commanded by Colonel Thomas Fleming in the Virginia line on Continental Establishment that in the Spring following [he] was promoted to an Ensigncy in said Regiment and served in that capacity until the Spring 1781 at which time I resigned in consequence of bad health and I do swear that I was a resident citizen of the United States on the 18th of March 1818 and that I have not since that time by Gift, sale or in any manner disposed of my property or any part thereof with intent thereby to diminish it as to bring myself within the provisions of an Act of Congress entitled an Act to provide for certain persons engaged in the Land and naval Service of the United States in the Revolutionary War passed on the 18th of March 1818 and that I have not nor has any person in trust for me any Property or Securities, contracts or Debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed, the Date of my pension Certificate is 4th of February 1819 and that he is not of any Occupation and has only 2 children who are Daughters living with him.

The Court is of Opinion that the property contained in the Schedule is of the value of \$60.

A Schedule of Joseph Payne's property

1 old man's saddle – 1 Horse & cow & calf, 1 water Pail, 2 small crocks, 2 tumblers, 4 old chairs – 2 wheels and 1 crock, some old earthenware, 1 pot,, 1 pot hooks and kettle, 1 pair smoothing irons, old shovel and tongs, 1 ax and 2 hoes, 1 set of knives and forks – some old lumber (Barrels and boxes)

[f p. 10: On September 12, 1837 in Bath County Virginia, Ann Payne, 76, filed for a widow's pension under the 1836 act stating that she is the widow of Joseph Payne, a revolutionary war pensioner for his service in that war; that he was "...taken prisoner and told her he was taken to Philadelphia where he was confined about eight months and was subsequently transferred to Long Island where she first saw him"; that she married him December 30, 1779 while he was a Prisoner of War; that they were married by Parson Van Cinder; that he was exchanged in 1780; that they removed to Goochland County Virginia where he shortly thereafter resigned his commission and then later moved in that year to Bath County where she still resides; that her husband died April 5, 1826.]

[Facts in file: The veteran was married either October 30 or December 30, 1779, both of which appear in the file; the maiden name of his wife is not stated; his widow died February 14, 1847 in Bath County Virginia; the veteran and his wife had the following children:

Richard born November 20, 1782

George V.C. born August 19, 1785

Cornelius born July 30, 1788

Jesse born December 25, 1790, died prior to 1807

Joseph born February 28, 1792

[Veteran was pensioned at the rate of \$20 per month commencing May 12, 1818, for service as an Ensign in the Virginia Continental line. Veteran's widow was pensioned at the rate of \$240 per annum commencing March 4th, 1831, for her husband's services as an Ensign in the Virginia service.]
