Pension application of Thomas Costner (Castner) W18856 Catharine f59NC Transcribed by Will Graves 12/8/10 rev'd 10/30/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of North Carolina Lincoln County: Court of Pleas & Quarter Sessions October Sessions 1832

On this 2nd day of November 1832 personally appeared in open Court before the Justices of the County Court of Pleas & Quarter Sessions now sitting Thomas Costner a resident of Lincoln County in the State of North Carolina aged eighty-five or six years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832. That he entered the service of the United States under the following named officers & served as herein stated. That in the year 1776, I was drafted in what was then Tryon County now Lincoln County to go in the Cherokee expedition & entered the service under Captain Hardin & marched in his Company to the nation but I am unable to state the name of the Colonel or General — while in that service we killed some Indians & took some prisoners & also in the nation we met with the forces from South Carolina the commander of them claimed the Indian Prisoners & they were given up to them. We also burnt some Indian huts & destroyed some corn — & after scouring the Country we were marched back to what is now Lincoln then Tryon County & discharged in this tour I served three months —

Afterward I was drafted in Lincoln County North Carolina in the year I cannot recollect for a three months tour & was placed under the command of Captain William Moore but I cannot remember the name of the Colonel or General but was marched to Wilmington North Carolina in Moore's company & remember having a little skirmish – that I am unable to state where it was – & after serving a tour of three months & a half I was discharged. He hereby relinquishes every claim whatever to a Pension or an annuity except the present & declares that his name is not on the pension roll of the agency of any State. Sworn to & subscribed this second day of November 1832.

A. In Lincoln County North Carolina then Tryon has lived there ever since –

4th How were you called into service; were you drafted; did you volunteer or were you a substitute, and if in substitute, for whom?

A. I was drafted

Q. Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it?

A. I was discharged by Captain Moore but it was not a written discharge.

State of North Carolina Lincoln County: This day personally came before me John Blackwood one of the Justices of the Peace for said County John Franibarger Sen. and after being duly sworn saith on oath that he the said Franibarger was in company with Thomas Costner Senior to Wilmington under the command of Colonel William Moore for the tour of [indecipherable word] then three months and that Thomas Costner some time previous to that was a tour to the Cherokee Nation after the Indians under the command of Captain Joseph Hardin but the length of time not remembered by the witness but it is supposed to be four months. Sworn to and subscribed before me this 31st day of October in the year of our Lord 1832

North Carolina Lincoln County: October Sessions 1832

Personally appeared William Moore² in open court & made oath in due form of law – & on oath saith that he was a Captain in the Revolutionary War – that Thomas Costner of said County served a tour of three and one half months under the said William Moore that he was marched to Wilmington in North Carolina – the tour ended about the 22nd of December 1781.

Jacob Plonk³ likewise came into court & made oath in due form of law & on oath saith that he was a soldier under said William Moore Captain at the same time with Thomas Costner. That they left home together – living in the same neighborhood at the time, that they marched to Wilmington, North Carolina together & that they were discharged by their same officer about 15 miles above Wilmington that he thinks the said tour must have been three months and a half – or thereabout.

[fn p. 9: on August 31st, 1846 in Lincoln County North Carolina, Mary McKelwain, made application for the pension due her mother under the 1838 act stating that she is the daughter of Thomas and Catharine Costner; that her father was a pensioner under the 1832 act for his service in the revolution; that her parents married sometime in the year 1784; that her father died July second, 1835; that her mother died November 28, 1842 still the widow of her father; that the names of all of the children and heirs at law all of her mother are Thomas Costner, Mary McKelwain, Joseph Costner, and Frederick Costner.] [In another document there is a note that a son named John had died prior to the death of their mother.]
