Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

On this 4<sup>th</sup> day of September 1843 personally appeared before the Subscriber One of the Justices of the Court of Pleas & quarter Sessions in and for said County Mrs. Frances Fail Resident of Johnston County aged 82 years who being first duly Sworn according to law doth upon her oath make the following declaration to obtain the benefit of the 3<sup>rd</sup> Section of the Act of Congress passed the 4<sup>th</sup> July 1836 and also benefit of the Amendatory act of the 3<sup>rd</sup> March 1837 that She is the widow of William Grimes who was a Soldier of the Revolutionary War that he enlisted in the Army of the United States in the Revolutionary War in the Spring of the year 1779 and served to the end of the War in Captain Dixon's [Tilghman Dixon's] Company, this declarant can only say what She has heard her late husband William Grimes declare repeatedly. That he Served in Captain Dixon's Company, was in South Carolina at Gates defeat [Battle of Camden, August 15-16, 1780] in 1780, and she knows he did not Return home until the latter part of the year 1781 after Cornwallis had passed through North Carolina on his way North, She further declares she was married to the aforesaid William Grimes in the month of June 1778 and her husband enlisted and left home the Spring afterwards, her marriage took place in Johnston County by John Bryan Esquire and her husband the aforesaid William Grimes died on the 6<sup>th</sup> day of March 1827 aged 70 that she intermarried on the 10<sup>th</sup> day of December in the year 1829 with Thomas Fail and that he died on the 7<sup>th</sup> day of September 1834, all which will more fully appear by Reference to prove hereunto affixed.



She signed her affidavit with her mark. p 12: Leacey's husband, David Adams, also filed a supporting affidavit.

I William Hill Secretary of State in and for the State of North Carolina, do hereby certify that it appears from the muster rolls of the Continental line of this State in the revolutionary war, that William Grimes a private Soldier in Captain Dixon's Company of the 10<sup>th</sup> Regiment was mustered in 1779 (the length of time for which he entered the service not mentioned). I find on a book of settlements, that William Grimes was allowed in one place, the sum of £15.19.0 and in another place the sum of £41.15.1 for his services in the said War, by a Board of Commissioners that sat at Halifax in 1784 & 1785; I do not find the name of William Grimes but once on the muster rolls.

This affiant Testifies and says that he was well acquainted with William Grimes deceased from the earliest part of his recollection and that he was with him in the Service during the Revolutionary War and knows of his own personal knowledge that William Grimes did Serve in the Army of the revolution and that he was generally esteemed by all who knew him to have performed the Service as stated by his widow Mrs. Frances Fail who is now applying for a pension. This affiant further states that he well Recollects that William Grimes was married to his wife Mrs. Frances Fail now applying for a pension in the month of June 1778 & have lived together as man & wife up to William Grimes' death which was on the 6<sup>th</sup> day of March 1827 that William Grimes soon after his marriage went into the Army and Served to be end of the War. This affiant lived near them all his life consequently had the opportunity of knowing their history well he further states that Mrs. Frances Fail who is now applying for a pension is a highly Respectable person and her Statement made the Relied on fully.
