[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

## State of South Carolina Union District: SS

On this twelfth day of stone January in the year of our Lord 1839 personally appeared before me John J. Pratt Judge of the court of ordinary for the District & State aforesaid Elizabeth T. Farr a resident of the District in State aforesaid aged seventy-five years who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed July the 4th 1836. That she is the widow of Lieutenant Colonel William Farr who was a Captain in the militia of the State of South Carolina, in the service previous to the 4th day of October 1779. That sometime after that period, the precise date not recollected by the affiant he was promoted to the rank of Lieutenant Colonel, which commission he held upwards of two years and until the close of the revolutionary war. That her husband the said William Farr served as Lieutenant Colonel under Colonel Thomas Brandon of the same State and District. She further deposes that the said William Farr was in the service as before stated previous to the 4th day of October 1779, but the precise date when he entered the service she is unable to state, and that he continued in the service until the end of the war. She does not know under what field officer he served about he was a Captain. That he resided in the District & State aforesaid when she first became acquainted with him which was some time previous to the said 4th day of October 1779 and that he was then in the service as a Captain, that he was a volunteer, that he was engaged in the following battles, to wit: the battle of Stono, Hanging Rock and the Cowpens, besides others as she is informed, and that she has no documentary evidence in her possession in support of her claim. She further declares that she was married to the said William Farr on the said 4th day of October 1779, that her husband the said William Farr died on the 2nd day of March 1794 and that she has remained a widow ever since that period, as will more fully appear by reference to the proof hereto annexed.

State of South Carolina Union District: SS

On this 14th day of January in the year of our Lord 1839 personally appeared Major Joseph McJunkin<sup>3</sup> of the District & State aforesaid before me John J Pratt Judge of the Court of ordinary of the same District in the State aforesaid, who being duly sworn deposes That he was acquainted with the late Lieutenant Colonel William Farr also of the said State & District before the revolutionary war, that sometime in the year 1776 he was commissioned a Captain of militia in the Regiment then called & known by the name of the Spartan Regiment commanded by Colonel John Thomas in the service of the said State. The other field officers were Lieutenant Colonel William Wofford & Major William Henderson. The company then commanded by Captain William Farr was known as Captain William Farr's company. That he continued to act as a Captain until the year 1778 – when some time in that year he was promoted to the rank of Lieutenant Colonel in the Regiment then called the second Spartan Regiment under Colonel Thomas Brandon the old Spartan Regiment having been divided, the other field officer of this second Spartan Regiment was Major \_\_ Bullock. That said Lieutenant Colonel William Farr continued in the service until the conclusion of the Revolutionary War in the said office of Lieutenant Colonel. This deponent further deposes that the said Lieutenant Colonel William Farr resided in the District & State aforesaid at the time that he entered the service of the State in the capacity of Captain as aforesaid & continued to reside there until the end of the war & until his death, that he was a volunteer, that he was engaged in the following battles, to wit: the battle of Blackstocks on Tiger River [sic, Tyger River] in the District aforesaid and the Cowpens in the District of Spartanburg, that he marched through various parts of South Carolina, from Union District to the Cowpens, Blackstocks & Hammond Store on Little River in the District now called Newberry to Ramsour's Mills in the State of North Carolina, to the Middle settlements & Valley Towns in the Indian country (the Cherokees) on the Hiwassee now a part of the territory of the State of Tennessee. This deponent further swears that he is acquainted with Mrs. Elizabeth T Farr the widow of the said Lieutenant Colonel William Farr who for whose benefit this deposition is made with a view to obtain the benefit of the act of 1836 "granting half pay to widows or orphans when their husbands or fathers had died of wounds received in the military service of the United States in certain cases & for other purposes." That the said Lieutenant Colonel William Farr as he was informed and believes was married to the said Elizabeth T Farr sometime in the fall of the year 1779. That from that time until his death, they were reputed and received as husband & wife, and raised a considerable family of children as such and he has no doubt that they were legally married. He further deposes that the said Lieutenant Colonel William Farr died previous to the year 1800, the precise time he does not recollect; and that the said Elizabeth T Farr has remained a widow ever since that period. This deponent further states that he was in the service of the State in the militia, as a private, in the year 1776, that in the year 1777 he was promoted to the rank of a Captain, and in the year 1780 he was promoted to the

rank of a Major and held that commission until the close of the revolutionary war.

On this thirteenth day of January in the year of our Lord 1839 Personally appeared Major Thomas Young<sup>4</sup> and Christopher Brandon,<sup>5</sup> both of the District & State aforesaid, before me John J Pratt Judge of the Court of Ordinary for the District & State aforesaid who being first duly sworn depose that they were acquainted with the late Lieutenant Colonel William Farr also of the said State & District before the revolutionary war, that in the year 1780 they entered the military service of the State as volunteer privates, that the said Lieutenant Colonel William Farr was in command some time in that year the precise time not recollected, as a Lieutenant Colonel, that he held the rank & command until the close of the revolutionary war and continued in the service of the State, as such until that period, that he served in the rank aforesaid in Colonel Thomas Brandon's Regiment & that Major Joseph McJunkin was the other field officer of said Regiment, that the said Lieutenant Colonel Farr resided in the now District of Union & State aforesaid – then called Ninety Six district. That he was a volunteer and that he was engaged in the battle of the Cowpens in the District of Spartanburg and as they are informed & believed in several other battles, that he marched from Union District into the State of North Carolina, Rowan County and through various parts of South Carolina. They further deposes that they are acquainted with Elizabeth T Farr the widow of the said Lieutenant Colonel Farr, that they were reputed and received as husband & wife, and raised a considerable family of children as such, and these deponents have no doubt that they were legally married, and that previous to the year 1780, they lived together and were accepted and considered as husband & wife. They further deposes that the said Lieutenant Colonel Farr died previous to the year 1800, and that the said Elizabeth T Farr has remained a widow ever since that period.
