Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina York District

This 18th day of March 1846 personally appeared before me, the subscriber one of the acting Magistrates in and for the said District Mary Hayes a resident of the District & State aforesaid aged eighty-one years, who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July 7th 1838, Entitled "An act granting half pay and pensions to certain Widows," Also the benefit of the Act of 3rd March, 1843 and June 17th 1844 –

That she is the widow of John Hayes late deceased of York District South Carolina who was a private Soldier in the South Carolina State Troops in the Army of the Revolution and as such he served the United States against the common enemy that he enlisted into Captain Barnett Company Colonel Hampton's Regiment Sumpter's Brigade of the State troops and served out a tour of duty in said troops & was discharged the length of said Enlistment supposed to be from 12 to 18 months. That besides the above tour of Enlistment he served several tours of duty in the militia and that he was in the Battle of the Eutaw Springs.

She further declares that she was married to the said John Hays on the 10th day of July 1783, and that her husband the aforesaid John Hays died on the 14 day of August 1817 in that she has remained a widow ever since that period.

She also declared that she has a family Record showing the date of her marriage, which was written down many years ago by her late husband and that the same is correct and true, and that the original Record is hereunto appended.

State of South Carolina York District: Personally appeared before me the subscribing Magistrate Robert Wilson<sup>3</sup> and after being first duly sworn according to law doth on his oath make the following affidavit

That he was in the days of the Revolution acquainted with John Hayes late deceased of York District South Carolina whose widow Mary is now applied for a Pension due her on the account of the Services of her late husband the aforesaid John Hayes deceased. That he deponent was a Soldier in the Revolution and knew of his own personal knowledge that the aforesaid John Hayes was a soldier of the same War. That he deponent knew him the said John Hayes as a Private Soldier in Sumpter's Troops and was with him at the Battle of Rocky Mount and in the Battle of Hanging Rock and the reason why he the deponent does so well recollect him the said John Hayes as a Soldier is that he the said Hayes had a Brother named James who was shot in time of the War in one of his arms & that him & his brother were together. This said deponent further declares that he saw the said John Hayes in Sumpter's camp at Haglers or Clems Branch.

There is a filed for a man by the name of John Hayes but it relates to his service in Nathaniel Martin's company of the 10 months State Troops. Unfortunately, it is not uncommon to encounter certificates in the federal pension documents relating to service in South Carolina which can no longer be found in its records.
