[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina district of Charleston}

On this twenty-seventh day of August in the year of our Lord 1838 before me Rob Elfe a Magistrate for the District of Charleston and State aforesaid personally appeared Mrs. Susannah Brown a resident of the City of Charleston, who being first duly sworn according to law, Doth on her oath make the following declaration in order to obtain the benefit of the third Section of the Act of Congress passed the 4th day of July 1836.

That she is the widow of Charles Brown who was a Lieutenant in the South Carolina Continental Line, that during the War of the Revolution. This deponent further declares that her husband the said Charles Brown, Entered the Army when quite a young man, at an early period of the war, and that he served to the end of the War. That he was engaged and rendered important services at the Siege of Savannah, was in the battle at Beaufort, and was in service at the Siege of Charleston when it capitulated [May 12, 1780] to the British forces -- This Deponent is unable to state particularly the nature and extent of the Services performed by her said husband but craves [?] reference to the records of the War Department, for more authentic testimony on this point. Deponent further says that a warrant for military land Bounty was a few years past awarded to the Heirs of the said Lieutenant Charles Brown by the Government of the United States for his military Services.

This deponent further swears that she was married to the said Lieutenant Charles Brown in the City of Charleston South Carolina, on the thirtieth day of October in the year 1783, as will more fully appear by the annexed certificate of marriage from the Parish Register of Saint Philips Church. This Deponent further deposes that she is now in her seventy second year, That her husband the said Charles Brown died in the year 1819 and that she has never married but remains his widow.

[p 7: On February 4, 1839, Christopher E. Gadsden, Rector of Saint Philips Church in Charleston South Carolina certified the following is a true entry on the records of that church: "Charles Brown and Susannah Tennant was married on the 30th, thirtieth, of October 1783,...."

[p 12: Copy of a resolution passed by the Senate and House of Representatives of the United States authorizing the issuance of a duplicate bounty land warrant number 2137 for 200 acres issued March 24, 1836 to Susan C. Brown, Sarah C. Brown, Charles T. Brown, Anna E. Brown, William T. Brown, E. Boudinot Brown, Sarah B. Keith, wife of John A. Keith, and Eliza Hopkins, surviving daughter of Susan Hopkins, being all legal heirs of Charles Brown deceased, who was a Lieutenant in the South Carolina line.]

[Veteran's widow was pensioned at the rate of \$320 per annum commencing March 4th, 1831 for her husband's two years service as a Lieutenant in the South Carolina line.]

[Note: There is a file in the SC Indents for a Charles Brown, file No. 801, 12 pages, but none of the documents in the file provide any specific information regarding the services of this Charles Brown.]<sup>5</sup>
