Pension application of Mathew Dalton W22503 Mary Dalton f22SC Transcribed by Will Graves 1/26/10: rev'd 3/23/20

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina District of Edgefield: SS

On this the 21st day of November 1838, personally appeared before the Honorable John Belton O'Neall one of the Associate Judges of the Courts of Session and Common Pleas of the State of South Carolina, Mary Dalton, a resident of Edgefield District & State of South Carolina, aged seventy-five years, who being first duly sworn according to law, doth, on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July 4, 1836: That she is the widow of Mathew Dalton, who was two years in the revolutionary war, as a private Soldier in the South Carolina Militia under General Pickens [Andrew Pickens] and Colonel Samuel Hammond, that he served a part of his time in Georgia as a volunteer under General James Jackson and General Clark [Elijah Clark]; that besides being in several small skirmishes, he was at the taking of Brown's, Greysons [sic, Grierson's]¹ and Galphin's Forts and fought at the battle of the Eutaw Springs [September 8, 1781];² that being advanced in years her memory is in this State as to dates and dates, that she cannot say with certainty when her husband the said Mathew Dalton entered the service of his country, but thinks it was sometime in the year 1781; that Colonel Samuel Hammond³ still lives and can testify in part, as to the truth of her declaration.

She further declares that she was married to the said Mathew Dalton sometime in the year 1782, the day and month of which, she cannot fix from a decay of memory, but is certain that her said marriage with the aforesaid Mathew Dalton took place before the last term of his Service expired; that her husband the aforesaid Matthew Dalton died on the 13 day of January 1836 -- and that she has remained a widow ever since that period, as will appear more fully by reference to the proof hereto annexed.

South Carolina Edgefield District: Personally appeared before me, Matthew Gray a Justice of the Quorum, in and for the District aforesaid, Colonel Samuel Hammond, who being duly, and

legally sworn, saith on his oath, that he was well acquainted with the late Mathew Dalton, that he was a Soldier in the War of the revolution, and served as a private in the State troops of South Carolina, under the command of this deponent for a term of at least ten months. This deponent further saith and deposes, that the declaration of Mary Dalton, the wife of the said Matthew Dalton, has been read in his presence, and that he has reason to believe and does believe, that the services of her husband as set forth there, is true. This deponent further saith and deposeth, that he is well acquainted with Mary Dalton (whose declaration is hereunto appended) that she is the asserted wife of the said Matthew Dalton, and was so received and regarded by the community in which they resided, and interior to the expiration of the last term of service of him the said Matthew Dalton in the war of the revolution, and continued to be so regarded ever since, during which cohabitation they had several children which are regarded as legitimate. Deponent has no doubt but what they were legally married at some period pending the revolutionary war. This deponent further saith that the said Matthew Dalton died some time in the year 1836, and that his wife Mary Dalton has remained a widow ever since.

[Veteran's widow was granted a pension in the amount of \$80 per annum commencing March 4th, 1831 for her husband service as a private for 2 years in the South Carolina militia and State Troops.]
