[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Virginia County of Spotsylvania: SS

On this 7th day of August appeared before the Justices of the County Court of Spotsylvania William Henderson a resident of and in the County of Spotsylvania and State of Virginia aged seventy-four years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed June 7th 1832. That he enlisted in the Army of the United States in the year 1778 with Lieutenant Samuel Peters and served in the ___ Regiment of the Virginia line under the following named Officers, to wit – Colonel Frank Taylor [Francis Taylor] of Orange and Major John Roberts of Culpeper County. He was in Albemarle, Augusta and Frederick County with Burgoyne's prisoners and also with them in Maryland. He was discharged from service in June 1781. He does not now recollect the number of the Regiment he enlisted in. Of the persons now alive John Stewart of Spotsylvania County served with him the whole tour.

He hereby relinquishes every claim whatever to a pension or annuity except the present and he declares that his name is not on the Pension roll of any Agency in any State. Sworn to and subscribed the day and year aforesaid

Declaration Continued and Amended

State of Virginia County of Spotsylvania: Personally appeared before me the undersigned a Justice of the peace in and for the said County the foregoing named applicant William Henderson who being duly sworn deposeth and saith that by reason of old age and consequent loss of memory he cannot swear positively as to the precise length of his service but according to the best of his recollection he served not less than the periods mentioned below and in the following grades – For three years & __ months I served as a militia man in the Virginia line and I can no further and [indecipherable word] particularly specify my said Service than in the annexed declaration and for such service I claim a pension.



[p 9: On June 9, 1855 in Anderson County Kentucky, Nancy Henderson, 85, formerly of Spotsylvania County now of Anderson County Kentucky filed a claim for her bounty land entitlement as the widow of William Henderson who died in Spotsylvania County Virginia March 10, 1836 and who was at the time of his death a revolutionary war pensioner at the rate of \$96 per annum. She signed this document with her mark.]

[p 10: On June 9, 1855 in Anderson County Kentucky, James Mason, 78, and John B. Mason, 31, gave affidavit in support of the claim for bounty land filed by Nancy Henderson. Their relationship, if any, to her is not stated.



[p 21: On June 9, 1855 in Anderson County Kentucky, James Mason, aged passed 78 years, gave testimony that he was well acquainted with William Henderson of Spotsylvania County Virginia about 40 years ago; that Henderson married the affiant's sister Nancy Mason in Spotsylvania about 30 years ago; that affiant left Spotsylvania County in the fall of 1834 or 1835 and that in 1837 his sister, the widow of William Henderson came to Anderson County Kentucky and continues to live there.]

[p 5: Certificate given by Robert Dabney as clerk of the Spotsylvania Virginia County Court indicating that records in his office show that William Henderson and Nancy Mason were legally married by John A. Billingsley a Baptist minister on January 5th, 1826.]

[Veteran was pensioned at the rate of \$80 per annum commencing March 4th, 1831, for service as a private for 2 years in the Virginia service. His widow was pensioned at a like amount until her pension was increased to \$96 per annum effective July 27, 1868
