Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Georgia County of Madison} Court of Ordinary September Term 1832

On this 3rd day of September in the year of our Lord 1832 personally appeared in open Court before James Anderson, John Meroney, Noah W Pittman and James Long, Justices of the Inferior Court now sitting as a Court of Ordinary Robert Carithers a resident of Captain Lea's Company district of Georgia Militia in the County of Madison and State of Georgia aged eighty-eight years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th, 1832.

That he entered the service of the United States under the following named Officers and served as herein stated, to wit: he entered as a Volunteer the 24th day of December 1780 as a private under the command of Captain Robert Anderson – Alexander Noble as Major and Andrew Pickens as Colonel – and continued to serve as a private until about the last of May 1781 - when he received a Captain's Commission and continued in the Service as Captain until the end of the war between England and America – and also continued to hold said Command until sometime in the fall Season of the year 1784 for the purpose of protecting the frontiers of South Carolina – he served General Morgan's [Daniel Morgan's] Army a short time before the battle of the Cowpens [January 17, 1781], he was ordered with a party of men to guard some public property – which duty he was performing when the battle of the Cowpens took place and by that means was deprived of being in the battle he resided in the District of Ninety Six in the State of South Carolina when he entered the Service under the Command of Colonel Pickens he was not in any regular engagement with the British Army but in Several Skirmishes with the Tories and Indians – in one of those he was wounded in the thigh – those Skirmishes were principally on the Frontier – after Joining Colonel Pickens Regiment as aforesaid he marched until he joined the Army under General Morgan (when he was detached to guard as aforesaid) after the battle of the Cowpens he again joined General Morgan and marched with the Army to Hillsboro North Carolina – when by orders from General Greene [Nathanael Greene] the troops under the command under Colonel Pickens returned to guard South Carolina from the depredations of the Tories and Indians – he was also at the Siege of Ninety Six [May 20-June 1917 81 he was not acquainted with any of the regular Officers only those before stated – he has lost or mislaid his Commission so that it cannot be procured – he has no Documentary evidence – but submits the affidavit of James McClesky¹ herewith enclosed.

He has no discharge – in answer to the Interrogatories 2 prescribed by the war Department and propounded by the Court he answered as follows to wit

Answer to first interrogatory – he was born in Lancaster County Pennsylvania the 30th day of March 1744 –

Answer to second Interrogatory – he has a record of his age at his own house

Answer to the third Interrogatory – he was living in the District of Ninety Six in the State of South Carolina he removed to Wilkes County in Georgia about the year 1790 – which was formed a part of Madison County and has resided in said County of Madison ever since Answer to fourth Interrogatory – he Volunteered

Answer to fifth Interrogatory – he has stated in his declaration all he recollects on that subject. Answer to sixth Interrogatory – he never received a discharge – and he has either lost or mislaid his Commission – he received his Commission from Governor Rutledge [John Rutledge] of South Carolina

Answer to seventh Interrogatory – he refers you to James Thompson – Robert Griffith, William Thompson, Robert Groves, James Long – Stephen Groves

He hereby relinquishes every Claim whatever to a pension or annuity except the present and declares that his name is not on the pension Roll of the Agency of any State.

Georgia Madison County Court of Ordinary May Adjourned Term 1833

Personally appeared James Carithers one of the Administrators of Robert Carithers deceased in open Court who after being duly Sworn on oath saith that Robert Carithers who made the annexed declaration departed this life the 4th day of October 1832, that this deponent can make no better showing of his Services then the said Robert made in his lifetime – with the Affidavit of James McCleskey herewith annexed – that it is reported and believed that the said Robert perform the Services as Stated in his declaration and the affidavit of James McCleskey.

² The War Department promulgated regulations governing pension application format and requiring the following 7 interrogatories to be put to each applicant for a pension:

^{1&}lt;sup>st</sup> Where and in what year were you born?

^{2&}lt;sup>nd</sup> Have you any record of your age and if so where is it?

^{3&}lt;sup>rd</sup> Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?

^{4&}lt;sup>th</sup> How were you called into service; were you drafted; did you volunteer or were you a substitute, and if a substitute, for whom?

^{5&}lt;sup>th</sup> State the names of some of the regular officers who were with the troops where you served, such Continental and militia regiments as you can recollect and the general circumstances of your service.

^{6&}lt;sup>th</sup> Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it?

^{7&}lt;sup>th</sup> State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for veracity and their belief in your services as a soldier in the revolution.

Came in person before me James McCleskey who being duly sworn saith that he was well acquainted with Robert Carruthers [sic] in time of the Revolutionary war with the United States of America & Great Britain & the Indians that he first knew him in the Militia Service in the State of South Carolina and Colonel Pickens Regiment under the command of General Williamson under Captain McCall on our march to Charleston before the fall but before we reached Charleston it fell and then General Williamson & Colonel Pickens them took Protection under Returned and then this deponent went to North Carolina and knew no more of Carruthers until the Siege of Ninety Six this deponent attached himself to a Rifle company at that Siege of which Company Robert Carruthers had the command and commanded one of the Redoubts I think in the 1781 after the Siege of Ninety Six General Pickens ordered Captain Robert Carruthers to raise a Horse Company to protect the frontiers of the State of South Carolina to which company this deponent attached himself under the command of the said Captain Robert Carruthers and served in said Company as a Spy the said Company the same until the close of the war this deponent thinks about two years and a half during which time the said Robert Carruthers had the Command of said Company.

[p 10: On November 12, 1851 in Madison County Georgia, Amos Carithers, 36, administrator of the estate of Mary Carithers, widow of Robert Carithers filed a claim under the 1838 act; he states that she married the veteran in Abbeville District South Carolina April 18, 1782; that the veteran died October 4, 1832 in Madison County Georgia; that Mary Carithers died February 8, 1842 leaving the following children surviving: Mary F Carithers and Margaret Carithers.

Mary Luckie was born the 24th September 1758


Robert Carithers and Mary Luckie was married April the 18th 1782

[p 29: On December 11, 1851 in Madison County Georgia Nancy Embry [also spelled Nancy Emery] gave testimony that she saw Robert Carithers and Mary Luckie married on April 18, 1782 in Abbeville District South Carolina. She signed her affidavit with her mark.]

[Veteran was pensioned at the rate of \$250.33 per annum commencing March 4th, 1831 & ending October 4th 1832; he was credited with 4 months and 15 days service as a private and 11 months and 23 days as a Captain in the South Carolina militia.]
