Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of North Carolina Cleveland County: Court of Pleas and Quarter Sessions August sessions 1846

On this 14th day of August 1846 personally appeared Elizabeth McSwain in open Court now sitting and after being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the act of Congress passed June the 7th 1832, that she is the widow of William McSwain deceased, who was a private Soldier in the North Carolina Continental line, and as such served the United States in the War of the revolution for the term of 18 months that he resided in the State of North Carolina, when he entered the Service, and that this Claimant now asks of the Government for a pension, which her husband the aforesaid William McSwain might have been entitled to had he applied in accordance with the above recited act of Congress, and this deponent further declares that she was married to the said William McSwain sometime in the year 1831, and that her late husband the aforesaid William McSwain died on the 9th day of December 1838, and that the paper purporting to be a transfer or sale of William McSwain his wages, for 18 months service in the Continental Service to John Carruth, was found by the executor James McSwain amongst the said William McSwain's valuable papers, and that the only reason why an application has not been made at an earlier day is that she did not know that she was entitled having been married to the said William McSwain at so late a period, and being his second wife. Transfer is hereunto appended. This deponent further declares that he is a Son & one of the heirs at law of the aforesaid William McSwain deceased. That the only reason why they did not make application at an earlier day for a Pension is that they were did not know that they was entitled until recently.

State of North Carolina Office of Secretary of State

I, William Hill, Secretary of State, in and for the State of North Carolina, do hereby certify, that it appears from the muster-rolls of the Continental line of this State, in the Revolutionary War, that William McSwain a private Soldier in Capt. Brevard's Company of the 10th Regiment, entered the service on the __ day of __ 1782 for the term of 18 months, and that he was transferred in March 1783. It appears on a book of settlements of the accounts of the Officers and Soldiers of the revolution that Wm McSwain no doubt the same man was allowed \$26.60/100 as one of the 18 months Drafts.

[p 10: On April 6, 1853 in Cleveland County North Carolina, Elizabeth McSwain, 74, filed for the pension due her husband as a revolutionary war soldier.]

[p 5: On March 29, 1855 in Cleveland County North Carolina, Elizabeth McSwain, 76 years old

a resident of said County, filed for her bounty land entitlement as the widow of William McSwain she signed this document with her mark.]

[Facts in file: Elizabeth, the widow, was 76 years old when she applied for her bounty land entitlement in 1855; she then lived in Cleveland County, NC; veteran's son, James McSwain, lived in Mooresboro, Cleveland County, NC in 1854.]

[Veteran was granted a posthumous pension in the amount of \$60 per Adam commencing March 4^{th} , 1831 and ending when he died December 9, 1838. The amount of his pension was based upon 18 months service in the North Carolina Continental line as a private. His widow was pensioned in a like amount.]
