Pension Application of Pierce Powers W24264 Mary Furber Navy NH Transcribed and annotated by C. Leon Harris.

State of New Hampshire }

County of Strafford } Ss. Farmington April 7th 1842

On this seventh day of April A.D. 1842 personally appeared before George L. Whitehouse a Justice of the Court of Common Pleas in and for said County and State, Mary Furber, a Resident in the County of Strafford and State of New Hampshire aged eighty five years, who being first duly sworn according to law, doth, on her oath make the following declaration, in order to obtain the benefit of the provision made by the act of Congress passed this July 4th 1836 and the act explanatory of said act passed March 3rd 1837. That she was married to Pierce Powers of Dover in said County and State, who was a Midshipman on board the Continental Ship of War Ranger Commanded by Captains John Paul Jones and Thomas Simpson and that the said Pierce Powers served as Midshipman on board said Ranger from October 1777 to May 1780 inclusive. That in March 1778 the said Pierce Powers had his right arm shot off in an engagement with the Enemy.

She further declares that she was married to the said Pierce Powers in Dover on the twenty fifth day of October one thousand seven hundred and seventy nine and that her said Husband the Pierce Powers died, in Boston on his way home from Charleston South Carolina, where he had been taken prisoner by the enemy [12 May 1780] on the 29^{th} day of June 1780 of yellow Fever, and that she was afterwards married to Richard Furber on the 12^{th} day of September 1786 with whom she is now living and that she was not the Mother of any child or children by the said Pierce Powers and that she has two children now living by the said Richard Furber [signed] Mary Furber In presence of Richard Russell/ John W. Furber

I Ezra Green [pension application S4303] of Dover in the County of Strafford and State of New Hampshire ninety five years old depose & say that in 1777 I entered as Surgeon onboard the Continental Sloop of War Ranger. John Paul Jones Commander and sailed in October of the same year and continued as Surgeon onboard said Ranger untill 1780. That I was acquainted with Pierce Powers, who was a Midshipman onboard the said Ranger during the above mentioned time from October 1777 to 1780 and that in the month of March 1778 the Ranger Captured the English Sloop of War Drake in the Irish Channel and that the said Pierce Powers had his right hand shot off and I amputated his arm above the elbow. The Ranger returned to Portsmouth New Hampshire in the fall of 1778 [15 Oct] under the command of Captain Thomas Simpson & he continued her Commander untill she was taken at Charleston South Carolina, and that I understood that the said Pierce Powers died in Boston on his way home from Charleston after the said Ranger was taken.

[The file includes a copy of the following extract of a letter by John Paul Jones in France to the Continental Congress:]

Brest May 27 1778

I lost only Lieutenant Wallingsford and one seaman (John Dougal) killed and six wounded among whom are the Gunner (Mr Falls) and Mr Powers a midshipman who lost his arm. One of the wounded Nath'l. Wills [Nathaniel Wills] is since dead. The rest will recover.

NOTES:

For further details of the *Ranger* see *Memoirs of Andrew Sherburne: A Pensioner of the Navy of the Revolution* published in 1831. Andrew Sherburne (pension application S42275) was a waiter for Powers on the *Ranger*.

On 12 June 1848 Daniel Fowler, 85, stated that in 1780 he was hired to work on the farm of John Wingate of Madbury NH, and while there John Wingate's sister, Molly "Mary" Powers lived with him. He also stated the following: "Not long before I commenced work with Mr Wingate he and his sister, Mary Powers, had been to Boston on account of the sickness of Mr Powers and when they came back, they said that Powers was dead. There were military clothes hanging in my chamber at Wingates which had belonged to Powers I was informed. The widow Powers had goods to sell which I understood fell to him Powers from Prizes which he had been engaged in Capturing from the enemy, among the articles were Rum Spice & tea."

The file includes a record of the marriage of Pierce Powers and Mary Wingate on 25 Oct 1779 officiated by Rev. Jeremy Belknap of Dover.

The file includes a copy of a petition to Congress for a pension, signed by Mary Furber when she was 85 and her husband was still living. It adds the following: "... in June 1780 your Petitioner was informed that her Husband was dangerously sick of Yellow Fever in Boston and that she imediatly set out on horse back, there being no other mode of traveling at that earley day and rode to Boston, it being eighty miles distance and when she arrived in Boston her Husband the said Pierce Powers had been dead two days and was buried."

On 4 April 1848 John W. Furber reapplied for a pension on behalf of his mother, Mary Furber, 92, "whose mental faculties are destroyed by her age." He stated that Richard Furber died on 14 March 1848.

September 1811

Their was a blazing Star [Great Comet of 1811, C/1811 F1] Rose at first in the East and Set in the northeast but Keept moving to the Left the Light Was seen for three month or more

September 23th 1815

When their was a hurracin [Great September Gale of 1815] from the provieance of Main to Providenc and to the State of Vermount which distroed a vaist number of shipping orchards groth of all kinds fances blown down a vast number of buildins and a grait number of Lives both of men woman & cattel Said winds was from the South East

May the 19 1780

there was a unversail Darkness over all North america [sic: New England's Dark Day] for 24 howers October 22 1785

When there wase a Delouge of Waters Over this Land or a freachett uncommon

July the 5 1803 When Farmington Metting House was Raised

October the 9 1804

When their was a Snow Storm [great 1804 "Snowicane" in the Northeast] said to be one feet deep in Sum

Places attended with Thunder & litting to a Great Degree and a uncommon winds and did a Grait deal of dammage by sea & land

Said Snow said to be four feet in the State of Vermount

December 26 1802 When their was a conforlagation by fier Dartsmouth [conflagration by fire at Dartmouth]

December 24 1806

When their was another fier in Dartmouth

December 22 1813 their was the gaties fier in portsmouth that Ever was known consumed about three hundred buildens

January 12 1814 another fier burnt the Rop walk

January the 19 & 20 1810

Was a colder tiem of Wather Ever Known and the hight wind blowed down many buildens or Rought many more and many people Parished and was frozen

June the first when 1811 their was a Grait fier [illegible word] as Ever Was Kown in this Countary in Newbury Port consumed near three hundred buildens of all Kinds

Rochester May the 14 1783 When Theodore Furber Returned from London and Was gone Eight year and ten Months

May the 10 1790

When Ca't [Capt.] Thodour Furbers Wife Mary Departed this Life at Saint Johns on bord the Ship Thomas

December 9th 1839 2½ of snow fell in 36 hours
