State of Illinois Coles County: SS

On this __day of March in the year of our Lord 1843, personally appeared; before the subscriber, one of the Judges of the County Commissioner's Court, in and for said County (the same being a Court of record) Ann Boyd a resident of the County and State aforesaid, aged eighty years, who being duly sworn according to law doth on her oath make the following Declaration in order to obtain the benefit of the act of Congress, passed July 4, 1836.

That she is the widow of John Boyd, who was an Orderly Sergeant in the Army of the Revolution and entered the service in the State of North Carolina: that she does not recollect under whom he served, nor the precise length of time he was in the service, but that he served during the greater part of the Revolution.

She further declares that she was married to the said John Boyd on the 16th day of November, 1779: that her husband, the aforesaid John Boyd, died on the 2nd day of December, in the year of our Lord 1814, and that she has remained a widow ever since that period; as will more fully appear by reference to the proof hereto annexed.

State of Illinois Coles County: SS: On this 16th day of May in the year of our Lord 1843, personally appeared: before the subscriber; one of the Judges of the County Commissioner's Court, in and for said County: (the same being a Court of Record) Ann Boyd, a resident of the County and State aforesaid; aged eighty years: who being first duly sworn, according to law, doth on her oath, make the following Declaration in order to obtain the benefits of the act of Congress, passed July 4th 1836: That she is the widow of John Boyd, who was an orderly Sergeant in the Army of the Revolution; that he entered the service, and the State of North Carolina: that she does not recollect at what time he entered the service, nor the precise length of his service which he served but thinks he served during the greater part of the Revolutionary War under General Rutherford; that he was at the shallow Ford on the River Atkin [sic, Yadkin River], at the time General Davis was killed.

She further declares that she was married to the said John Boyd, on the 16th day of

November 1779: that her husband, the aforesaid John Boyd, died on the 2nd day of December in the year of our Lord 1814; and that she has remained a widow, ever since that period: that she knows of no Record of the marriage, except the annexed leaves marked A.

[fn p. 8: on December 1, 1845 in Coles County Illinois, Alpha Bolch [sic, Alpha Balch] filed a declaration seeking the benefit of the act of July 7th, 1838 stating that she is the daughter of Ann Boyed [sic], widow of John Boyd; that she is the only child of John and Ann Boyd; that her mother Ann Boyd died March 19, 1844.]

[fn p. 10: On December 14, 1844 in Iredell County North Carolina, Hugh Andrews, 93, gave testimony that he was acquainted with John Boyd and his wife Ann Bone, the daughter of James Bone in Rowan County (later Iredell); that they lived together as man and wife; that they had no children when they removed from the state of North Carolina.]

Raleigh, North Carolina Office of Secretary of State 7th of June 1843 James L Edwards Esquire Commissioner of Pensions Sir

You will see by the letter here with sent (which is sent because I cannot make out the writers name) that I am requested to state to use something respecting the time Sergeant John Boyd served in the revolutionary war, in my certificate of the 13th of April last I stated all that the musterrolls shows respecting him, but I see he obtained a land warrant for three years and four months service, which goes to prove that he served after 1779, as his service appears to have commenced in 1777.

State of North Carolina Office of Secretary of State

I William Hill Secretary of State in and for the State of North Carolina, do hereby certify, that it appears from the musterrolls of the Continental line of this State in the revolutionary war, that John Boyd a Sergeant in Captain McRee's company of the 6th Regiment enlisted sometime in the year 1777, the term for which he enlisted not mentioned, He was a private in June 1778, a Sergeant again in November 1779. It also appears of record in this Office, that a warrant for 476 acres of land was issued on the 11th of November 1784 for the services of said John Boyd as a Sergeant in the Army aforesaid for the term of 3 years and 4 months, which warrant was issued on the certificate of a Field Officer of said Army.

[Veteran's widow was pensioned at the rate of \$100 per annum commencing March 4th, 1831 and ending March 19 1844 when she died. Her husband was credited with one year's service as a private and one year's service as a Sergeant in the North Carolina Continental line.]
