Pension application of Jeremiah Munday¹ W2636 Chloe (Cloe) Munday f46VA²

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of North Carolina Lincoln County

On this 2nd day of May 1818 before me the subscriber one of the Judges of the Superior Court of Wall & Courts of Equity for the said State personally appeared Jeremiah Munday aged 55 years resident in Lincoln County in said State, who being by me first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress entitled "an act to provide for certain persons engaged in the land & naval service of the United States in the revolutionary war:" That he the said Jeremiah Munday enlisted in the State of Virginia in the County of Essex in the company commanded by Captain Thomas Buckner of Colonel William Heath's [William Heth's] detachment of Scott's [Charles Scott's] Brigade of the Continental Army; that he continued to serve in the said Corps or in the service of the United States from the month of April 1779 until the month of May 1780 when he was taken prisoner at Charleston South Carolina afterwards escaped from the enemy, joined the Army at Chesterfield Court House & served until October 1780 when he was discharged from service at Chesterfield County State of Virginia, that he was in the battles of siege of Charleston, when taken by the British in May 1780, and that he is in reduced circumstances, and stands in need of the assistance of his country for support; and that he has no other evidence in his power of his said services.

[p 34: James Younger testified in Essex County Virginia on October 3rd, 1818 that Jeremiah Munday volunteered in the revolution to serve as a soldier sometime in the month of April 1779.]

I do Certify that Jeremiah Munday was a Soldier in Captain Thomas Buckner's Company William Hiths Regiment & General Scott's Brigade in the Continental Service and I served with him from Me 1779 until May 1780 at which time we were both taken prisoner at Charlestown South Carolina.

The affidavit of Reuben Smith Senior⁴ of lawful age & first sworn on the holy Evangelist of Almighty God Deposeth & saith that he was acquainted with Jeremiah Monday [sic] in the Revolution War that we were Stationed together in the town of Petersburg in Virginia from the month of May till October following in the year 1779 and from thence we marched to Charleston in South Carolina together in Colonel William Heath's Battalion or Detachment in General Stoct's [Scott's] Brigade & that the said Monday was in Captain Thomas Buckner's Company & we stayed in Charleston until the Town was taken by the British in the month of May 1780 & we were both taken prisoners & further he says not.

County of Lincoln State of North Carolina: October Sessions 1827

On this 25th day of October 1827 personally appeared in open Court, for the County of Lincoln Jeremiah Munday aged about sixty-seven years, who being first duly sworn according to law, doth on his oath make the following declaration, in order to obtain the provision made by the acts of Congress of the 18th of March 1818 and the first May 1820. That he the said Jeremiah Munday, enlisted (as well is he remembers) in the spring of 1779 in the State of Virginia for the term of 18 months in the company commanded by Captain Thomas Buckner in the Regiment commanded by Colonel William Heath in the line of the State of Virginia on the Continental establishment; that he continued to serve in the said Corps until he was taken prisoner at Charleston South Carolina in May 1780, making his escape from the British, joined the American Army at Chesterfield Court-House Virginia, having served out the term for which he was enlisted, was discharged by Colonel Davis or Davison. That he hereby relinquishes every claim, whatever to a pension except the present: that his name has been placed on the pension list, that the number of his pension certificate is 7928 dated 18th of March 1819 and that he never before exhibited a schedule of his property because, being discouraged by many as to any prospect of being again restored to the pension list.

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress

entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed viz.

I am indebted fully upwards of \$120 and there is due to me about \$30 a part of which small sum I will lose owing to the insolvency of individuals us indebted: My occupation is that of a farmer, old age and infirmity has rendered me unable longer to maintain myself and a large helpless family without the assistance of my country. My wife near fifty years of age delicate & often afflicted with pains. My son Osbourn is in his 21st year, will be subject to my commands, not longer than the next summer. My daughter Patsey resides with me and is 18 years old labors for herself, those two heretofore have mainly contributed to my support and that of a large family of children unable to give much assistance, Jeremiah age 14, Spencer aged 12, Fletcher 10, Chloe 8, Munroe 5, Elizabeth an infant. That since March 1818 but little change in my property has taken place save the loss by death of one good horse, which I was then possessed of any other change has been in my stock, was killed for the use of my family.

[p 12: On October 18, 1848 in Lincoln County North Carolina, Cloe Mondy [sic] filed for a widow's pension under the 1848 act stating that she is the widow of Jeremiah Mondy [sic], a revolutionary war pensioner at the rate of \$96 per annum; that she married him sometime in the month of November 1798; that he died 11 September, 1835; that they were married in Pittsylvania County Virginia; that she has no record of her marriage but has a record of the dates of the births of her children. She signed her application with her mark.]

[p 7: On April 30, 1855 in Lincoln County North Carolina, Chloe Mundy [sic], 76, filed for her bounty land entitlement as the widow of Jeremiah Mundy [sic]; her name prior to her marriage was Shelton. She signed this application with her mark and her name was spelled "Chloe Mondey"]

[Veteran was pensioned at the rate of \$8 per month commencing May 2, 1818, for service as a private in the Virginia Continental line. His widow was pensioned at the rate of \$96 per annum commencing March 4th, 1848.]
