Pension application of Charles Pelham¹ W3034 Isabella fn50VA Transcribed by Will Graves 8/1/11

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

The Commonwealth of Kentucky First Judicial District Sct.

Charles Pelham a resident Citizen of the County of Mason and District and Commonwealth aforesaid, this day made the following declaration before me Adam Beatty Circuit Judge of the District and Commonwealth aforesaid: to wit, That he the said Charles Pelham entered the military service of the United States in the month of February in the year 1776 as first Lieutenant of a company commanded by Captain Edmund Dickinson in the first Virginia Regiment on Continental establishment, commanded by Colonel Patrick Henry; and that shortly after he received a commission as first Lieutenant of the Company and Regiment aforesaid.

That on the 11th day of November in the same year, he was commissioned a Captain in the same Regiment. That on the 23rd day of November in the year 1779 he was commissioned "a Major of the 2nd Virginia Regiment in the Army of the United States to take rank as such from the 25th day of June 1779"; and that he continued in the Army and service of the United States from the time that he first entered it, as aforesaid, until the end of the War of the revolution, and until the troops were disbanded. He further declares that he never had a pension heretofore allowed him by the laws of the United States, and that by reason of his reduced circumstances in life, he needs the assistance from his country for support

And I the said Adam Beatty, Circuit Judge as aforesaid further certify that the said Charles Pelham did, before me, in due and legal form, make oath to the truth of the facts stated in the foregoing declaration.

In witness whereof I the said Adam Beatty Circuit Judge as aforesaid have hereunto set my hand and seal the 13th day of April 1818

State of Kentucky Sct.

At a Court held for the Mason Circuit at the Courthouse in the town of Washington on Wednesday the 21st of May in the year 1823.

Charles Pelham produced in Court a declaration and schedule in conformity to the act of Congress in such case made and provided and swore to the same, which is ordered to be filed and it is ordered to be certified to the Secretary of War, that this Court is satisfied from the evidence of Milton Taylor, sworn in open Court, that the property set forth in said Schedule, is of the value of \$218.18 exclusive of the land on which the said Pelham lives, which is of the annual

value of \$13.33.

The declaration and schedule referred to in the above order is in the following words and figures, to wit:

State of Kentucky, County of Mason Sct.

Be it remembered that at a Court held for the Mason Circuit in the County of Mason and State of Kentucky before the Honorable Adam Beatty sole Judge thereof on the ___ day of May 1823 personally appeared in open Court Charles Pelham resident in the said County aged 74 years and 10 months who being first duly sworn, according to law, doth on his oath make the following declaration, in order to obtain the provision made by the acts of the 18th of March 1818 and the 1st May 1820 and the 1st of March 1823, that he the said Charles Pelham having for some time served as a private soldier in a volunteer company commanded by a Captain James Jones and in a minute Company commanded by Captain Robert Anderson was appointed a Lieutenant in January or February in the year 1776 and a Company commanded by Captain Edmond Dickenson in the first Virginia Regiment on Continental establishment commanded by Colonel Patrick Henry, where and in which capacity he served until the early part of the year 1777 when he was appointed a Captain in the said first Virginia Regiment, then commanded by Colonel Isaac Read, and afterwards received his commission dated November 11th, 1776 where he the said Charles Pelham continued to serve until the summer of the year 1779 when he was ordered to join the 2nd Virginia Regiment on Continental establishment commanded by Colonel Christian Febiger as Major thereof, and on the 20th day of June 1779 was commissioned as Major, which commission the said Pelham forwarded among other papers to the Secretary of War, about 5 years ago, in order to obtain a pension under the act of the 18th of March 1818. The said Pelham further states that in the year 1779 aforesaid, he marched under Brigadier General Woodford, to Charleston South Carolina, where he was captured by the surrender of the town, to the British troops by Major General Lincoln, in May 1780 and continued a prisoner until the end of the War; That he was in the battle of White Plains, Brandywine, Germantown and Monmouth; was in the cannonade at New Brunswick first December 1776 and in the defense of Mud Island Fort, nearly the whole siege.

And I the said Charles Pelham do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed; nor any other property of any kind or description, necessary clothing and bedding excepted, than that named in the following Schedule to wit

The said Charles Pelham states that he receives annually from the Cincinnati Society of Virginia \$100 that he has some debts due to him which (except a debt from the United States to him of \$25) in consequence of insolvencies and the long periods that have elapsed since they were due, he has long relinquished all hopes of ever collecting any part of, and that he owes several large debts which he has no hopes of ever being able to pay, and several smaller debts which he is unable to discharge.

That he has a lease for life for one third part of an undivided tract of about 90 acres of land, on which he lives and about 20 acres of which land, only is cleared, and cultivated. The said Charles Pelham also states, that he has no occupation, nor has he ability to pursue any. That his family consists of himself, now in the seventy fifth year of his age, his wife in the fifty seventh year of her age, His daughter Elizabeth Atkinson Pelham, in the thirty first year of her age, Martha M Pelham in the twenty ninth year of her age, (both unhealthy) Penelope Pelham in the twenty third year of her age; and Ann Crease Pelham in the fifteenth year of her age; and who is unhealthy; His sons William Pelham in the twenty first year of his age and who is about to leave him, John Pelham in the eighteenth year of his age and Richard Henry Pelham in the eleventh year of his age, he has also two grandsons living with him to it James E Pelham, in the ninth year of his age and George H Pelham in the seventh year of his age.

[fn p. 11: On August 28, 1838 in Mason County Kentucky, Isabella Pelham, 73, filed for a widow's pension under the 1838 act stating that she is the widow of Charles Pelham late a major in the Army of the revolution in the Virginia line and a pensioner of the United States; that she

married him September 22nd, 1874 in Caswell County North Carolina by John Womack; that her husband died August 29th, 1829; that she knows of no person she can prove her marriage by except her brother General Atkinson of the United States Army was living with her at the time of her marriage; she submits the following family record as proof of her marriage.

the 25^{th} of February 1776 and is now a Prisoner of War: – Given under my hand this 3^{rd} day of April 1783
