Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Pennsylvania city & County of Philadelphia: SS

On this twenty first day of September in the year of our Lord 1842 personally appeared before the Judges of the Court of Common Pleas in & for the City & County of Philadelphia Sarah Massey, a resident of the District of Southwark (on Swanson Street, four doors South of Queen Street) in the County of Philadelphia, in the State aforesaid: aged 68 years: Who being first duly sworn according to law, doth on her oath make the following declaration in order to obtain the benefit of the provisions made by the Act of Congress passed July 7th A.D. 1838, entitled an Act granting half pay & pensions to certain Widows: That she is the widow of Caleb Massey who served as private Soldier in the Continental Army of the Revolution for three years, in the Virginia Line, in the 9th Regiment, that he enlisted in Captain George Gilchrest's Company attached to the aforesaid Regiment, that he was taken Prisoner at the Battle of Germantown [October 4, 1777], and that he was regularly discharge, as will more fully appear from the Certificate of Colonel John Cropper, given many years ago. That the Military Bounty Land of 100 acres to which her said Husband was entitled by virtue of said Services, was by him conveyed to Thomas W Bailey in the year A.D. 1807.

She further declares that she was legally married to the said Caleb Massey, on the first day of May A.D. 1792 in the County of Worcester in the State of Maryland, by the Reverend William Downing, but that she has not any Certificate or Record thereof – & That her husband died on the 6th day of May A.D. 1827 – that she was not married to him prior to his being discharged the service, but that the marriage took place previous to the first day of January A.D. 1794, to wit the time & place herein before stated.
