[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Virginia, to wit:

On this 23rd day of October 1832 Personally appeared before the Court of the County of Halifax William Buntin a Resident of the County and State aforesaid, aged 68 years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed the 7th June 1832. This applicant states that he was a resident of Amelia County State of Virginia at the time he served in the Revolutionary War, and served one tour in the Militia under the command of Capt. Edward Mumford between Petersburg & Old Jamestown and received his discharge of General Joseph Jones in the town of Petersburg. The 2nd tour he served under Capt. John Oglesby joined the troops at Chinkepine Church under Regular Officers, Meriwether & Lookus [sic, Lucas?], and marched from there to headquarters crossing Haw River at High rock Ford and went on with General Green [sic, Nathanael Greene] to Guilford where we had one engagement [March 15, 1781] after which I was discharged by General Greene at Ramsey's Mill on Deep River. And he served two other tours under Capt. John Dennis & Osborne at Little York and from there over the Rappahannock & between the Rappahannock and the Potomac Rivers and was discharged at Amelia Court house by Capt. Dennis, each tour counting at three months but he was sometimes kept over that time. That he claims only one year of his service as a soldier in the Revolutionary war -- that he was born in Amelia County State of Virginia about the year 1764, that his register was left in Amelia County, that he has lived in Halifax County since the Revolutionary War, and does now live in the same County, that his discharge he lost on the bank of James River by taking out some money, he supposes. -- That he knows no living person at this time by whom he can prove his services in the Revolutionary War. He hereby relinquishes every claim whatever to a pension or annuity except the present and that his name is not on the Pension Roll of the Agency of any State.

the said County of Henry personally appeared William Buntin, who, on his oath, declares that he is the same person who formerly belonged to the Company commanded by Capt. Osborne, in the Regiment commanded by Col. Benjamin Blount in the service of the United States; that his name was placed on the pension roll of the State of Virginia from whence he has lately removed; that he now resides in the State of Tennessee, where he intends to remain, and wishes his pension to be payable, and future. The following are his reasons for removing from Virginia -- He has a daughter living in Henry County Tennessee, that he came out to visit & has concluded to reside there the balance of his days.

[p 9—On March 24, 1885, in Henry County, Tennessee, Nancy Buntin, 81, filed as the widow of William Buntin stating that she married him "near Mouth of Sandy, in Henry County, Tennessee about the __ day of Dec. A. D. 1837"; that they were married by one Crawford Bradford, JP; that her name before her marriage was Nancy Smoot; that her husband was a pensioner at the rate of \$40/annum until his death in Henry County, Tennessee, 'about 10th day of March 1841. She signed her application with her mark.]

[Facts in file: In another filing in 1885, the widow states that her husband had be previously married in Virginia; that she learned of this from her husband and his son-in-law John Wilson (who, if living (in 1885) lives in Missouri, her husband's daughter, wife of said John Wilson, being now deceased; in this document the widow states she married William Buntin on November 12, 1837 at her own residence near "Mouth of Sandry Henry County, Tenn." That her husband was living with his son-in-law in Henry County, Tenn., when the marriage took place and continued to live with him until his death in 1841. p 13: A summary of the contents of the file indicates that the veteran was married first two Elizabeth (maiden name not stated) who died November 1, 1834 in Virginia; that in 1837 the veteran had a daughter (not named) who was the wife of John Wilson and living in Henry County Tennessee; the veteran's 2nd wife Nancy was the widow of Samuel D Smoot.]

[Veteran was pensioned at the rate of \$40 per annum commencing March 4th, 1831, for service as a private for one year in the Virginia militia. His widow was pensioned at the rate of \$8 per month.]
