Pension application of Thomas Canaday (Kenneday, Keneday, Kennedy) W3561 Nancy Canady 52NC Transcribed by Will Graves 11/2/10 rev'd 10/4/14

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina Duplin County: SS: Court of Pleas & Quarter Sessions

On this the 26th day of November 1832 personally appeared in open Court, before the Stephen Graham, William K Frederick [?] & Gibson Sloan now sitting, Thomas Canaday or Kennedy of said you County, who will be seventy years of age on the 20th of August next: who being duly sworn according to law, doth on his oath make the following declaration, in order to obtain the benefit of the Act of Congress passed June 7th, 1832. viz. That he enlisted in the regular service in Duplin County in the year of the battle of Eutaw Springs [September 8, 1781], for the term of 12 months, and was attached to the company commanded by Captain Joseph Rhodes [Joseph T Rhodes] which company he believes was attached to the first Regiment being commanded by Major Blount and Colonel Murfby or Murfree; from Duplin, he marched to Hillsboro, thence to Salisbury, there he was stationed for a short time – from thence by Charlotte and Camden to Thompson Fort on Santee [River]; being headquarters and under the command of General Greene [Nathanael Greene]. From thence he marched to Eutaw under the command of General Greene and was in the battle of that place (which occurred in August or September) as he believes. After the battle of Eutaw, he marched under the command of General Greene to the high hills of Santee thence to Bacons Bridge, From thence under the command of Captain Benjamin Coleman, he was marched to Wilmington North Carolina where he was discharged, having served in said service 12 months as above set forth –

I hereby relinquish every claim whatever to a pension or annuity, except the present, and declare that my name is not on the Pension Roll of the Agency of any State.

Amended declaration of Thomas Kenneday made in open Court at the Court of Pleas & Quarter Sessions and is August Term 1833 Duplin County North Carolina

The Applicant does not distinctly remember the year which he served but knows it was the year of the Battle of the Eutaw Springs because he was engaged in that action – And the

following interrogatories were propounded & answered in open Court viz.

Where & in what year were you Born, Answer – in Currituck in August 1763.

Have you any Record of your Age & if so where is it, Answer – I have none

Where were you living when called into service – Answer – In Duplin County

Where have you lived since the Revolutionary War, Answer – in Duplin County

Where do you live now – Answer – in Duplin County

How were you called into service – Answer I volunteered

Did you receive a discharge – Answer – I did it is lost said discharge was given by Captain Coleman in Wilmington North Carolina

Did you ever receive a commission Answer – No

I refer you to the Miller Solr, J. K. Hill Shff. J. Pearsall clerk S court, JE Watkins Clerk C. Court & a great number of other respectable Citizens of Duplin County for my character –

State of North Carolina Duplin County Court of Pleas & Quarter Sessions November Term A.D. 1833

The foregoing declaration of Thomas Canaday is returned for the following – 1st – to state the year in which the service was performed

2nd – to prove by living witnesses his service or that no such witness can be found –

Now Thomas Canaday maketh oath that he joined on the 25th of May 1781 & continued until the first of June in the following year, as our Captain would not discharge us until the first of the month –

2ndly – I David Quinn, hereby make oath that I joined in Duplin County with Thomas Canaday who has subscribed & sworn to the foregoing declaration and affidavit, that I served with him the whole 12 months as above stated in the same Company & under the same officers – & that the statement made by him is according to the best of my knowledge & belief true in all its particulars.

I David Carlton hereby make oath that Thomas Canaday who has subscribed & sworn to the foregoing affidavit was in the camp of General Greene at Bacon's bridge in South Carolina in the year 1782 that he was discharged shortly after I joined, as I understood that his time was nearly out.

[p 13: On March 15, 1853 in Duplin County North Carolina Nancy Kenneday, 78, filed for a widow's pension stating that she is the widow of Thomas Kenneday, a pensioner of the United States for his service in the revolution; that she married him about 57 years ago in Duplin County but does not remember the month or the day of the month in which she was married; that her husband died February five, 1851 in Duplin County; and that she remains his widow.]

[fn p. 18: on April 18, 1854 in Duplin County North Carolina,, 74 last November testified that he is the brother of Nancy Kennedy widow of Thomas Kennedy; that he was an eyewitness to their marriage; that the marriage took place at the residence of his father Robert Bishop in Duplin County when affiant was about 17 years old or on or about December first 1796; that the marriage was performed by Robert Sutherland a justice of the peace; that his sister and Thomas Kennedy were married 50 odd years and had nine children.]

[p 19: on April 18, 1854 in Duplin County North Carolina, Willis Bishop, 49, verified the family record showing the birth dates of the children of Thomas Kenneday in the handwriting of this affiant copied from a family record 20 years ago; that Thomas Kenneday was twice married, had six children by his first wife they is James, Joseph, John, David, Felix & Daniel, & 10 by his last wife Nancy his present widow of whom one died young little over four years old the other nine are still living.]

I William Hill Secretary of State in and for the State aforesaid, do certify that it appears from the musterrolls of the Continental line of this State in the revolutionary war, that Thomas Canady a private in Captain Doherty's [George Dougherty's] Company of the 10th Regiment entered the service in 1781 for the term of 12 months and that his time was out the 25th day of May 1782, and that nothing more is said of him on said rolls.

Given under my hand this second day of July 1836, at office in Raleigh S/Wm Hill

[Veteran was pensioned at the rate of \$40 per annum commencing March 4th, 1831, for 12 months service as a private in the North Carolina Continental line.]
