Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky, Adair County Court January Term 1833

On this 7<sup>th</sup> day of January 1833 Personally appeared in open Court before the worshipful Justices of the County Court in and for the County of Adair State of Kentucky now sitting John Grider Senior a resident of the County of Adair aforesaid and State of Kentucky aged 77 years the 13<sup>th</sup> of July past, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June the 7<sup>th</sup> 1832. That he entered the Service of the United States of America in the County of Burke in the State of North Carolina in the month of March 1778 as a volunteer private militia man under Captain Thomas Whitson Lieutenant John Morgan does not recollect the name of his Ensign he was immediately marched to Davidson's station on the frontier of North Carolina he remained there a short time when he was marched on towards the Cherokee Nation having Joined some other troops he had marched but a few days when he was taken sick & returned with some others back to the Fort where he remained until he regained his health and again resumed his duty as a soldier his business being to guard the Fort and act as an Indian spy, in which character he continued until his officers and company returned from the Cherokee Nation and still continued there spying, scouting and guarding the Fort until a few days after Christmas when he was verbally discharged and returned home having served over nine months, he states that Early in March 1779 he again volunteered as an Indian spy under Captain Forgey [Samuel Forgay] and entered the service of the United States immediately in that character and was marched on to the said Davidson's Station when his bounds as a spy was assigned to him by his Captain and he faithfully discharged the duties assigned him until after Christmas when he was again Honorably discharged by his Captain and Returned home having in the last mentioned tour served more than nine months he again entered the service as a volunteer in the character of an Indian spy under Captain Daniel Smith Lieutenant Brown in the month of February 1780 and was marched on to the station stated above and there continued to discharge his duty as by and guarding that and other forts until after Christmas when he was again Discharged making in actual service in the said three tours of upwards of two years and four months he states that he took no written discharge for any of his services nor has he any documentary Evidence of his service but he can prove at least most of his service by Valentine Grider,<sup>2</sup> Samuel Smith<sup>3</sup> and Rachel Smith of Cumberland County Kentucky, who were all unable to attend this Court but whose affidavits he has procured & will cause the same to be hereunto annexed he states that he was born in the State of Maryland in the year 1755 agreeable to the information of his parents which he believes to be true he has no register of his birth his father moved to Virginia when this declarant was young and settled in Caroline County from there he moved to North Carolina and settled in Burke

County bear his father died before the revolution this declarant remained in that Country until the year 1811 when he moved to Kentucky Adair County where he now lives & has ever since he hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any state Sworn to and subscribed the day and year aforesaid.

State of Kentucky, Cumberland County

Be it remembered that on this 12<sup>th</sup> Day of December 1832 Personally came before the undersigned Justice of the peace in and for the County aforesaid Valentine Grider a resident of Cumberland County State of Kentucky aged about 71 years who being first duly sworn on the Holy Evangelist of Almighty God states that he is well acquainted with his brother John Grider Senior a resident of Adair County Kentucky that said John is 77 years of age that he and the time of the Revolution resided in Burke County North Carolina He further states that said John Grider served as a private Militia man in the service of the United States during the revolutionary war Three tours of duty on the frontier of North Carolina he states that he served with him two tours which was the last two said John served and he well recollects his serving one tour before this affiant was in service he knows he went and returned that he went Early in the Spring & returned about Christmas following and in the two tours he served with this affiant the term was about the same length he has no hesitation in stating that said John in the three tours aforesaid served more than two years he thinks said John first entered the service in 1777 or 1778 and served Each succeeding year he further states that he is now so infirm that he cannot without much inconvenience to himself attend the Court of Adair Sworn to and subscribed the day & year aforesaid before me.

State of Kentucky, Cumberland County

Be it Remembered that on this 12<sup>th</sup> day of December 1832 personally came before the undersigned Francis H. Winfrey one of the Commonwealth's Justices of the peace in and for the County of Cumberland County aforesaid Samuel Smith a resident of the County aforesaid who being first Duly sworn according to law doth on his Oath state that he is well acquainted with John Grider Senior now a resident Citizen of the County of Adair State of Kentucky that he has been well acquainted with him for upwards of 50 years this affiant is now in the 77<sup>th</sup> year of his age and he states that the said Grider is about the same age and that he knows that said Grider was a Soldier of the revolution from the County of Burke State of North Carolina he states that about the year 1777 the said Grider was stationed with this affiant at Grider's Fort Davidson Fort & scouring about from Early in the Spring until about Christmas in this tour he has no doubt the said John Grider Senior served as a private Soldier in the Service of the United States at least nine months Captain Thomas Whitson was the Commander John Morgan was the Lieutenant he further states that he has no hesitation in stating that the said John Grider Served two other tours of about the same length of time in the same service and in the same region of Country he cannot state positively not having been with him but he knows he the said Grider was absent and report said he was in Service and when he would return it was so reported by him & others and generally so Believed & never was doubted this affiant is as Confident He the said Grider served the two last tours here mentioned as he can be of any thing that he did not witness throughout this

affiant further states that he is old and so infirm that he is unable to attend Court for the purpose of giving his testimony in the above case.

Also the affidavit Rachel Smith aged 75 years who being duly sworn according to law doth on her oath states that she is the sister of John Grider Senior of the County of Adair and the same person named by Samuel Smith & Valentine Grider in their depositions above, she states positively that her said Brother John did served three tours of Duty as a militia man in the revolutionary war in the service of the United States she knows of his starting from home each tour and his returning home that each year he started early in the year and would returned about Christmas she cannot certainly state the length of time in each tour But feels confident that Each Tour was between eight and nine months she recollects that he went out Early each year & returned about Christmas she further states that she is old and infirm so much so that she cannot without great inconvenience and trouble attend Court.

State of Tennessee, County of Henderson

On this fifteenth day of November 1836 before me the subscriber a Justice of the Peace for the said County of Henderson, personally appeared John Grider Senior who on his Oath declares, that he is the same person who formerly belonged to the Company Commanded by Captain Thomas Whitson and the Regiment commanded by Colonel Charles McDowell in the second tour of the Company commanded by Captain Daniel Smith, in the Regiment commanded by the said Colonel Charles McDowell, in the third Tour in the Company commanded by Captain Samuel Forgey in the Regiment Commanded by the aforesaid Colonel Charles McDowell in the Service of the United States, that his name was placed on the Pension Roll of the State of Kentucky from whence he has lately removed, that he now resides in the State of Tennessee, in the County of Henderson where he intends to remain and wishes his pension to be there payable in future --

The following are his reasons for removing from the State of Kentucky to the State of Tennessee – that he had a Son Mr. Silas Grider, living in Henderson County Tennessee to whom he was fondly attached, and who was both able and willing to take care of them and to provide for him and to afford him those comforts and consolations attendant upon old age and infirmity.

[p 12: On September 22, 1853, in Henderson County, Tennessee, Isabel Grider, 93, filed for a widow's pension stating that she is the widow of John Grider, a revolutionary pensioner in Henderson County Tennessee on October 3, 1838; that she married him in Burke County North Carolina in 1781; that they

were married by John Connally a Justice of the Peace; and that her maiden name was Isabel Blair. She signed her application with her mark.]

[p 13: On September 22, 1853 in Henderson County Tennessee, Silas Grider, 57 a resident of said County gave testimony that he is the son of John Grider and that his father gave him a power of attorney to draw his pension money and that he, affiant, went to Jackson in September 1838 Andrew the money at Union Bank.]

[p 90: On February 17, 1854 in Henderson County Tennessee, Silas Grider a resident of said County gave testimony of the family record; that same is in the handwriting of Noah Douglass and was made in the spring of 1821; that the record of his age is correct; that he had one sister and 7 brothers older than himself not one of whom are twins and they are the children of John and Isabela Grider.]

[p 59: On July 22<sup>nd</sup>, 1854 in Russell County Kentucky, James Grider, 70, a resident of said County gave testimony authenticating the family record of his parents John and Isabel Grider; he states the family record has been in his possession for 48 or 50 years; that he, John Grider was born in 1783 and his sister Barbara Mandans is older than himself.

Ip 20: In May 1855, in Henderson County Tennessee, Isabel Grider, 97 filed for her bounty land entitlement as the widow of a revolutionary war pensioner. She signed this document with her mark. Her execution of this document was attested by Silas Grider and S E Grider whose relationship to the widow is not stated.

[Veteran was pensioned at the rate of \$80 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 2 years in the North Carolina militia. His widow was pensioned in a like amount.]
