[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Virginia Fauquier County: SS

On this 30th day of July 1838 personally appeared before me a Justice of the peace in the County aforesaid, Hannah Lear, a resident of the said County aged seventy-one years, who, being first duly sworn, according to law, doth on her oath make the following declaration, in order to obtain the benefit of the provision made by the act of Congress, passed July 7th, 1838 entitled "An act granting half-pay and pensions to certain widows:" That she is the widow of William Lear, who was a private in Captain Rogers's Company of Cavalry in the Illinois Regiment, commanded by Colonel Clark [presumably George Rogers Clark]. She further declares that she was married to the said William Lear on the __ day of August 1787 in the County of Fauquier aforesaid by the Reverend Parson Thompson; That her husband the aforesaid William Lear died on the 15th day of February 1816. That she was not married to him prior to his leaving the service, but the marriage took place previous to the first day of January 1790, viz. at the time above stated.

Virginia Fauquier County: SS: This day William Carver a credible witness aged 75 years personally appeared before me a Justice of the peace in the aforesaid County and made oath that he has been acquainted with the within named Hannah Lear, about forty-eight years and with her late husband the within named William Lear from that time until his death; that he remembers said Lear received bounty land for his Revolutionary Services & sold it to one Aaron Moore, of Shenandoah County Virginia – He also states on oath that the said Hannah Lear has remained a widow ever since the death of said William Lear. Given under my hand this 30th day of July 1838.

[p 27: in a affidavit dated March 16, 1843 filed in **Fauquier County** by the widow then giving her age as about 76, she appears to have signed this document as follows

Hannak Jean

[Veteran's widow was pensioned at the rate of \$100 per annum commencing March 4th, 1836 for her husband's service in the Illinois Regiment as a cavalryman.]

[Note: There is an 8 page file containing documents whereby Mary and James Lear of Fauquier County Virginia made a claim for bounty land due their father, William Lear for services under a Captain "Rodgers". In addition, there is an affidavit given by James Lear, brother of William Lear, in which he says his brother served 3 years under a Captain "Rodgers." Unfortunately the documents in this file are so poorly copied as posted online that they could not be transcribed in whole. Consequently, I did not attempt to make transcriptions of the small portions thereof that can be discerned. Based on the fact that the claim was made in Fauquier County and that the veteran William Lear is said to have served under a Captain "Rodgers", I thought it possible that this documentation may relate to the above referenced veteran. It is possible, however, that it relates to an entirely different veteran by that same name.]
