[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of North Carolina Chatham County: Court of Pleas & Quarter Sessions August Term A.D. 1832

On this 15th day of August personally appeared in open Court before the Justices of said Court now sitting Daniel Ellington a Resident of Chatham County in the State of North Carolina aged seventy-two years who being first duly sworn according to law doth on his oath make the following declaration in order to attain the benefit of the act of Congress passed June 7th 1832.

That he entered in the service of the United States under the following named officers and served as herein stated early in the Revolutionary War he was drafted in the County of Bute and the State of North Carolina and joined the company of Militia commanded by Captain Twitty [John Twitty], Lieutenant Henry Hunt and Ensign Daniel Burford he marched with his company southwardly through Fayetteville crossed drowning Creek at Coles Bridge and entered South Carolina 12 miles beyond he performed his Tour in the Edge of South Carolina he joined no Regiment and was in no battle the service was principally designed to act against the Tories he received a written discharge from the service after he had served four months he does not recollect who signed his discharge and has lost the same long since.

Sometime after his discharge as aforesaid he was again drafted in the North Carolina Militia in the County of Warren formerly Bute County and joined the Company under the command of Captain Clanton [Edward Clanton], Lieutenant William Singer and Ensign John Allen he marched with his company to Franklin County and joined the Regiment Commanded by Colonel Benjamin Seawell in Lieutenant Colonel William Brickle he marched with the Regiment to Cheraw Hill in South Carolina when our Regiment was joined by another Regiment of North Carolina militia under the Command of Colonel Jarvis whilst he was in Cheraw the Battle of Camden [August 15-16, 1780] was fought whereupon he was marched into Chatham at Ramsey's Mills on Deep River in North Carolina from thence he was marched to Salisbury from thence to Charlotte from thence to the Waxhaw settlement in South Carolina where we were joined by a Regiment commanded by General Davidson [William Lee Davidson] who remained but a few days when they moved up the Catawba and General Davidson was killed [February 1, 1781 at the Battle of Cowan's Ford] the Division to which he was attached marched to Charlotte thence to the Island Ford of the Yadkin at which place the American horse had a slight engagement with Tarleton's [Banastre Tarleton's] Horse which resulted in the defeat of the Americans at the Island Ford he was discharged after having served five months his discharge was signed by Captain Clanton which he has long since lost --

Sometime after his discharge as aforesaid he was again drafted in Warren County and

joined the company of North Carolina Commission commanded by Captain Joel Wren, he marched with his company from Warren to Granville and joined Head quarters at Williamsborough under General Allen Jones, he joined the Regiment commanded by Colonel Linton [William Thomas Linton] and Major Wood, he marched with his Regiment from Williamsborough [Williamsboro] to Halifax, thence to Kingston [Kinston] on Neuse River, thence to Tarborough [Tarboro], thence to little River thence to some short distance below Wilmington where he received his discharge after having served for five months his discharge was signed by Colonel Linton which is now lost –

He has no documentary evidence and knows of no person whose testimony he can procure who can testify to his services

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the Pension Roll of the agency of any State.

[p 8: On June 2, 1842, in Chatham County North Carolina, Sarah Ellington, Eighty, made application for a widows pension stating that she is the widow of Daniel Ellington, a revolutionary pensioner at the rate of \$46.66 per annum; that she married him August 13, 1779 and that he died January 4, 1833.

[Facts in file: the widow died April 17, 1844 survived by the following children: Nancy Riddle, Cary Riddle, Fanny Cooper and Sarah Bolling.]

[Veteran was pensioned at the rate of \$46.66 per annum commencing March 4th, 1831, for service as a private for 14 months in the North Carolina militia. His widow was pensioned in a like amount.]
