Pension application of James Gilmore W4207 Transcribed by Will Graves Mary Gilmore f44NC 8/10/08 rev'd 8/28/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Georgia, Washington County

On this the tenth day of December in the year of Christ 1832 personally appeared before the Justices of the Inferior Court now sitting for ordinary purposes James Gilmore a resident of the County of Washington and State of Georgia age seventy-eight years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provisions made by the act of Congress passed June seventh, 1832. That he was drafted and joined the Army at Elizabethtown North Carolina in 1778 and served in the company of Capt. John Welch, John Painter Major, Philip Alston Col. and Ash [sic, John Ashe] – General and Bryan Lieutenant-General. For which service the deponent has a discharge ending 20th March 1779 was in the battle at Brier Creek Georgia [March 3, 1779] and afterwards was in several scouting parties and in frequent skirmishes with the Tories was again drafted in 1781 and substituted one Thomas Moore for three months and was in a scouting party of horse for thirty-one days ending 4th September 1781 for which he has also a discharge from Samuel Gilmore Capt.

That he resided at the time in Cumberland County North Carolina.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not entered on the pension list of agency of any State.





State of Georgia, Washington County

On this 22nd day of July 1833 personally appeared in open Court James Gilmore a resident of the County of Washington and State of Georgia aged Seventy eight years who being first sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed June 7th, 1832. That he was drafted and joined the army at Elizabethtown North Carolina in 1778 – and served in Company of Capt. John Welch, John Pointer – Major – Philip Alston Col. and Ashe General and Bryan Lieut. General for which service the deponent has a discharge ending 20th March 1779 a tour of six months was in the Battle of Brier Creek State of Georgia and afterwards was in several scouting parties and in frequent skirmishes with the Tories was again drafted in 1781 and substituted one Thomas Moore for three months also was in a scouting party of horse for 31 days ending 4th September 1781 for which the deponent has a discharge. That he resided at the time of his being drafted in Cumberland County State of North Carolina.

To the first interrogatory he answers that he was born in Cumberland County North Carolina 13th of November 1755.

To the second that he has a record of his age in his possession as left by his father

To the third, that he was living in Cumberland County North Carolina when called into service that he has lived in Rowan County North Carolina and now is living in Washington County State of Georgia.

To the 4th that he was drafted --

To the 5th that he has given the names of Officers and circumstances

To the 6^{th} that he has received discharges herewith annexed – that he was a corporal and sergeant in his 1^{st} tour.

To the 7th that there are no persons in the neighborhood who knew anything of his services as a soldier in the Revolution.

The deponent hereby relinquishes every claim whatever to a pension or an annuity except the present and he declares that his name is not on the Pension Roll of any Agency in any State.

[W. P. Haynes, a clergyman, and T. J. Warthern gave the standard supporting affidavit.]

[p 12: On 27th day of January 1840, in Washington County Georgia, Mary Gilmore, 74 years old, filed for a widow's Pension under the 1838 act stating that she is the widow of James Gilmore a pensioner of the United States at the rate of \$20 per annum for his services in the Revolution; That she married him on June 6, 1779 and that he died on January 3, 1835. She signed her application with her mark.]

[p 15: On March 9, 1840 in Washington County Georgia the widow filed an amendment to her declaration in which she states that the date of her marriage as set forth in her original declaration was incorrect; that she had based her statement solely upon her memory but by reference to the family record she finds that the marriage took place June 6, 1780; that she now exhibits the prayer Book in which the family record is recorded and has been kept by her. She signed this document with her mark.]

[Veteran was pensioned at the rate of \$20 per annum commencing March 4th, 1831, for service as a private for 6 months in the North Carolina militia. His widow was pensioned in a like amount.]
