Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Virginia pension Claim

For the purpose of obtaining the Benefit of an act for the relief of Certain Surviving Officers & Soldiers of the Revolution approved on the 15th of May 1828 I Philip Hupp of the County of Monroe & State of Ohio Do hereby declare that I enlisted in the Continental line of the Army of the Revolution for & During the War and continued in its service until its Termination at which Period I was a Private in Captain Cope Sullivan's Company in the thirteenth Regiment of the Virginia Line. I also declare that I afterwards Received a Certificate for the Reward of Eighty Dollars to which I was Entitled on the Resolve of Congress passed the 15th of May 1778 & I further Declare that I was not on the 15th of March 1828 on the Pension list of the United States.

Philip Hupp of __ in the County of Monroe in the State of Ohio has applied to the Secretary of the Treasury for the benefits of the act, entitled "An act for the relief of certain surviving officers and soldiers of the Revolution," approved the 15th of May, 1828. He states that he enlisted in the Continental line of the Army of the Revolution, for and during the war, and continued until its termination, at which period he was a private in Captain Sullivan's Company, in the __ regiment of the Virginia line; and that he received a certificate for the reward of eighty dollars, provided by the resolve of the 15th of May, 1778; and further, that he was not on the 15th of May, 1828, on the pension list of the United States, and that he has received as a pensioner since the 3rd of March, 1826, nothing

On this 21st day of January 1837 personally appeared before me Samuel Powel a Justice of the Peace in and for the said County Mary Hupp a resident of Enoch Township Monroe County Ohio aged 78 years who being first duly sworn as the Law Directs on her oath doth make the following Dicteration [Declaration] in order to obtain the Benefit of the Provisions Act of Congress passed on the 4th day of July 1836 that She is the widow of Philap Hupp [sic] who was a private in the Armey [Army] of the Revolutionary War of the United States and bielve [believe] that he served in the Virginey [Virginia] Line. She further declares that she was Maried [married] to the said Philap Hupp in the County of hampshire in the State of Virginia on or about the 23rd day of July 1782 that her husband the aforesaid Philap Hupp died on the 9th day of November 1832 – and that she has remained a widow ever since that Period as will more fully Appear by reference to the proof hear to [hereto] Anext [annexed]. Sworn to & Subscribed on the day & year above written before me.

Veteran's widow was pensioned at the rate of \$80 per annum commencing November 9, 1831, for her husband service as a private in the Virginia Continental line.]







Here is my feeble attempt to decipher the above:

I Certify that Philip Hupp served as a Soldier in the Marine Service under the command of Captain Willing on an Expedition from Fort Pitt down the Mississippi from the 10th day of January 1778 [last digit very faint and unclear] to the 3rd day of June 1779 inclusive for which services he is entitled to be paid by Captain Jas. Willing [James Willing]² or the United States. [Several lines of text too faint for me to discern any but of few miscellaneous scattered words.]

² Gwathmey has the following entry for Capt. James Willing:

Willing, James, Captain in Navy; commanded the Rattletrap on an expedition to New Orleans in Dec., 1777; appears in Capt. O'Hara's Co. at Fort Pitt in Mch., 1778; appears on a list of prisoners at Long Island taken at sea dated Dec. 7, 1778.
