Pension application of Andrew Baxter (Beaxter) W4635 Elizabeth Baxter f76NC Transcribed by Will Graves 7/17/08 rev'd 9/1/14

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 2] State of Georgia, Carroll County

On this nineteenth day of October 1839 personally appeared before me James H. Rodgers a Justice of the Inferior Court of the County and State aforesaid Elizabeth Baxter a resident of the said County and State aged Seventy five years who being duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July 7<sup>th</sup>, 1838 entitled "an act granting half pay and Pensions to certain widows" that she is the widow of Andrew Baxter who was a first Lieutenant of light dragoons and served a ten months tour as a volunteer and she believes that Major Davy [sic, William Richardson Davie] since General Davie was his officer and that General Irvin was the General that he served in different capacities some times as a scout some times in pursuit of the Enemy in reconnoitering his out posts and also that he went one trip if not more against the Cherokee Indians and that he was off and on in the service for the most of the war he was a citizen of Mecklenburg County North Carolina and that while he was a first Lieutenant of light dragoons he was taken prisoner as will show by his parole and that he was prevented from serving actively after that time as he was never exchanged the Country in which he served was from his native place to Charleston South Carolina and indeed all through those two states near the line between them he obtained for his services at one time two Negroes who were given as pay for some part of his services. She has forgotten most of what she knew she has heard him relate the battles in which he was engaged but does not now recollect them. She further declares that she was married to the said Andrew Baxter on the eighth of January 1784, that her husband the said Andrew Baxter died in the month of September or October 1816 that she was not married to him prior to his leaving the service but the marriage took place previous to the first of January 1794 (viz.) at the time above stated.



[p 21: On May 23<sup>rd</sup> 1839, Thomas W Baxter and Ann Wiley gave testimony that they were well acquainted with Andrew Baxter deceased husband of Elizabeth Baxter an applicant for a pension under the 1838 act; that they were present when Andrew Baxter died which took place on or about October 4, 1816 at the residence of Ann Wiley near Milledgeville in the County of Baldwin Georgia.

## Georgia, Cass County

Personally appeared before me Henry Loyless an acting Justice of the Inferior Court of the County and State aforesaid Hugh Brewster<sup>2</sup> who being duly sworn Deposeth and saith that he was in his youth a citizen of Mecklenburg County in the State of North Carolina that he is now upwards of Eighty years of age, that he was in its use well acquainted with Andrew Baxter of the County & State last aforesaid and that the said Baxter was the junior of deponent, as deponent believes, and that he the said Andrew Baxter was a Soldier in the War of the Revolution, that he entered the Army during the latter part of the service as a private soldier under Captain Martin [Nathaniel Marshall Martin] and Major Davie's Battalion and served three months: and that he Baxter afterwards served a term of ten months as a first Lieutenant under Captain Martin in Col. Wade Hampton's Regiment. They were termed "Light Dragoons, State Troops," Baxter was always a very stout and energetic soldier & Officer, and that the said Baxter was taken prisoner by the British and kept in confinement in Charleston for some length of time, and has no knowledge of his being in the service afterwards. And that sometime after the war closed, he was, previous to the first day of January 1794, married to the daughter of Thomas Harris Esq. of Mecklenburg County and State of North Carolina, but does not know the given name of the Lady.

Personally appeared before me Alfred J. Camp an acting Justice of the Inferior Court for the above County and State William Brewster<sup>3</sup> Senior who being duly sworn Deposeth & saith that he was in his youth a citizen of the State of North Carolina Mecklenburg County and that he is now upwards of Eighty Two years of age that he was in his youth well acquainted with Andrew Baxter of said County and State and that Andrew Baxter was somewhat his junior and that he the said Andrew Baxter was a soldier in the war of the Revolution that he entered the Army at or about the time it was half through that he served in different capacities and that he was in different Corps sometimes serving as a Soldier and sometimes as an officer that he was at one time as high up in office as Captain or first Lieutenant of Light Dragoons but I am unable from length of time and loss of memory to state the names of any of his officers or the Corps in which he served, he also says that he was accounted as good & active Soldier and officer and that he was taken Prisoner by the British and kept for some considerable length of time in Charleston South Carolina and this Deponent further states that he was Discharged upon parole from Charleston this Deponent went to see him to hear the news and he further states that the said Andrew Baxter was not again in active Service on account of his parole he further states that he knew Elizabeth Harris daughter of Thomas Harris Esq. of said County and State of North Carolina who was afterwards married to the said Andrew Baxter and who is the person now about to make application for a pension under the act of Congress passed July 7th, 1838 entitled an act granting half pay and pensions to certain widows and that although this Deponent was not present at their marriage yet from common report he knows they were married having [been] acquainted with both the parties previous to that after their marriage and that day were not married until after the peace with Great Britain but before the first of January 1794.

[p 73: On October 19, 1839 William G Springer gave testimony in Carroll County Georgia that the widow Elizabeth Baxter was living with his family at that time and was still a widow.

Personally appeared before me Albert Alexander an acting Justice of the peace for said County and State George Alexander<sup>4</sup> who after being duly qualified Deposeth and saith that he was a soldier in the Revolutionary war and is nearly seventy-six years old and that he was personally acquainted with Andrew Baxter of Mecklenburg County North Carolina and that said Baxter was older than deponent says does not recollect the day nor month that he entered the service But on the 10<sup>th</sup> of July 1780 he was engaged with him the said Baxter as a private in the Battle of Hanging Rock [August 6, 1780] in South Carolina in Captain Martin's company of volunteers Major Davie's Battalion (afterwards General Davie) of three months men and that said Battalion was discharged in August of 1780 and said Baxter entered as a first Lieutenant in Captain Foster's company of ten months men in March 1781 in Colonel Henry Hampton's Regiment in General Sumter's [Thomas Sumter's] Brigade of State Troops of South Carolina Rendezvoused at Winnsborough in South Carolina they marched [from] said place and took Fort Granby [May 14, 1781] on Congaree River and that he was taken prisoner at Dorchester<sup>5</sup> 20 miles from Charleston South Carolina and that he was confined in Charleston a considerable time and served no more during the war in both Troops he served as a light dragoon this deponent further saith that said Baxter married Elizabeth Harris Daughter of Major Thomas Harris of Mecklenburg County North Carolina he believes in January 1784 previous to the first of January 1794 shortly after his marriage he emigrated to Georgia and [lived] there since in Georgia and knew them to be the same – he thinks he died about the year 1816 or '17 and that the applicant is the widow of Andrew Baxter Deceased.

[p 12: On August 22, 1846 in Carroll County Georgia, Eliza T Baxter gave testimony that her mother Elizabeth Baxter applied for a pension for the services of her husband in the revolutionary war; that her mother died May 4, 1844 in Carroll County Georgia where she had lived for the last 16 years of her life; prior to that time she had resided in Hancock County; that her mother was survived by the following children: Thomas W Baxter, Mary Springer formerly Mary Baxter, Eliza T Baxter and Eli H Baxter; that Thomas W Baxter has since died leaving the following children Andrew, Mary, Thomas, Sarah, John, Leroy, Edwin and Richard Baxter.

[Facts in file: The widow, Elizabeth Baxter died May 4, 1844 in Carroll County, Ga. survived by the following children: Thomas W Baxter, Mary Springer, Eliza T. Baxter, Eli H. Baxter; that Thomas W. Baxter died after his mother's death leaving the following children: Andrew, Mary, Thomas, Sarah, John, Leroy, Edwin and Richard Baxter.; John Springer served as administrator of the estate of Elizabeth Baxter, widow of the veteran; Elizabeth Harris Baxter was the daughter of Major Thomas Harris of Mecklenburg County, NC; she was living in the home of William G. Springer in Carroll County, Ga. at the time of her death.]

[Veteran's widow was pensioned at the rate of \$310 per annum commencing March 4, 1836, for her husband service for 3 months as a private and 18 months as a Lieut. of dragoons in the North Carolina service.]
