Pension Application of Littleton Chandler W4651 Transcribed and annotated by C. Leon Harris Susan Chandler VA

At a Court held for the County of Accomack, on the 28th day of August 1832.

Susan Chandler widow of Littleton Chandler this day personally appeared in Court and made the following declaration in order to obtain the benefit of the act of Congress passed on the 7th day of June 1832 viz. State of Virginia, County of Accomack Sc. On this 28th day of August 1832, personally appeared before the Justices of Accomack Court, Susan Chandler, relict of Littleton Chandler a resident of the County & State aforesaid who being first duly sworn according to Law doth on her oath make the following declaration in order to obtain the benefit of the Act of Congress passed June the 7th 1832: That she intermarried with her deceased husband Littleton Chandler in the year [blank] that they lived together man & wife until the 4th day of July last past when her husband Littleton Chandler departed this life; That she had frequently heard him speak of his services in the Militia during the Revolutionary war that she verily believes he served more than two years, that she does not know whom he served under; that she is informed Benjamin Colonna [pension application \$46634] knows of his services, that her deceased husband resided all his lifetime in the County of Accomack. That it is generally believed in the neighbourhood where he died that he was a soldier of the revolutionary war. That he was well acquainted with Isaac Smith surveyor of the County also George P. Scarburgh Prosecutor for the Commonwealth in the County Court of Accomack aforesaid, that the said Littleton Chandler was born March 11th, 1761 as appears from the family record of his age, that she believes he entered the said service in the year 1777 and continued in service till the end of the Revolution. She hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that her name is not on the pension Roll of the agency of any state, nor is that of her husband so far as she knows or believes. - Sworn to & subscribed the day and year aforesaid. Susan her Xmark Chandler

[John G. Joynes made the following statement: "I visited the said Littleton Chandler in his last illness but a few days previous to his death, and that I then had a conversation with the said Littleton Chandler in reference to his services as a Soldier of the Revolution, and that in that conversation the said Littleton Chandler informed me, the said John G. Joynes, that he entered the Service of the state of Virginia, in the Militia of the said State in the said County of Accomack in the year 1777, and that he continued in the said Service till the end of the Revolutionary War, and that the said Littleton Chandler was at the time of the said conversation very ill, and that his death was then daily expected by his friends."

[22 Mar 1851] I Benjamin Colonna of Accomack County and State of Virginia aged eighty nine years, a Revolutionary soldier do hereby certify that I lived in the immediate neighbourhood of and was well acquainted with Littleton Chandler and I am positively certain that he served in the Revolutionary War. He was in the Company Commanded by Captains Joynes and George Oldham which were attatched to the regiment commanded by Colos. Southey Simpon [sic: Southy Simpson] and George Corbin. To my certain knowledge all of the militia Companies in this County were frequently called out to guard and defend exposed situations in the County. From my knowledge of the service of the Companies Commanded by Captas Joynes and Oldham, I am confident Littleton Chandler was on Military duty more than two years, but of the exact time he was in service I cannot after this long lapse of time say with accuracy
