## Southern Campaign American Revolution Pension Statements & Rosters

Pension Application of John Etherington (Eatherton) W4670 Susan Etherington VA Transcribed and annotated by C. Leon Harris. 19 Jan 2014.

At a Court held for Spotsylvania County the 6th day of April 1818.

John Etherington of Spotsylvania County came into Court and made oath that he enlisted in this County under Captain Gustavus B Wallace [Gustavus Brown Wallace] of the 3rd Virginia regiment on the Continental establishment and served three years and upwards in the revolutionary war, and produced to the Court a certificate from the said Gustavus B Wallace, and one from John Blackwell who was a captain in the said regiment setting forth that he was a soldier in the said regiment. And he further declares on oath that from his reduced circumstances he stands in need of the assistance of his country for support.

[The discharge is much damaged.]

This is to certify that Jno Etherington enlisted in the  $3^d$  V R on Continental establishment in My Comp'y. for three years from [illegible] 1777 was taken at Ch's. town [Charleston SC, 12 May 1780] and

discharged at Wmb'g. [Williamsburg] in July 1781

Gus B. Wallace/ Lt. Colo 2<sup>d</sup> VR

I do certify that John Etherington was a soldier in the 3<sup>d</sup> Virgi'a. Reg't. on Continental establishment during the revolution, and served part of the time for which he was inlisted in my Company of the said Reg't. and was captured at Charles Ton, his conduct as a soldier was meritorious and deserved the particular attention of his Country, to the best of my recollection there was another man of the same name in Wallace's Company, which Company the above named John Etherington served part of his time.

At a Court Continued and held for Spotsylvania County the 7th day of June 1820 District of Virginia Sct.

On this 7th day of June 1820 personally appeared in open Court being a court of record by the laws of the state John Etherington aged sixty eight years resident in Spotsylvania County in said District who being first duly sworn according to law doth on his Oath declare that he served in the revolutionary war as follows That about the month of August 1777 he enlisted as a soldier for the term of three years in Captain Gustavus B. Wallace's Company of the third Virginia Regiment commanded by Col John Heath [sic: William Heth] of the Virginia line that he faithfully served his time and was discharged by Col Gustavus B. Wallace at Charlestown in the month of July 1781 that he was in a battle at Charlestown [sic: siege of Charleston, spring 1780], his original declaration was made before the Court on Spotsylvania County in the state aforesaid on the 6th day of April 1818 his pension certificate in No 1352 and dated the 24th day of July 1818 and I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18<sup>th</sup> day of March 1818 and that I have not nor has any person in trust for me any property or securities contracts or

debts due to me nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed to wit, One hundred and thirty acres of poor land, One horse, three Cows and two yearlings, nine sheep, one plow and one harrow, four hoes One axe, one cart, one sow and six shoats my occupation is cultivating the aforesaid land. My family consists of my wife only who is about fifty seven years of age.

[On 4 Nov 1823 Etherington made a new pension application similar to the preceding, stating that he had been dropped from the pension roll because he owned too much property. His new schedule of property was as follows:]

130 acres of poor land one horse one Cow and calf, one sow and six shoats three sheep one axe two hoes one plow one harrow one old Cart that since the exhibition of my first schedule the following changes have been made in my property vizt;

six sheep three killed for same use and three died. Two hoes paid to a man for cutting fire wood. And further that the occupation of him the said Etherington is that of a farmer that S. E. Etherington his wife aged about sixty years resides with him that from their old age and infirmities they are unable to support themselves by cultivation of the land before described and that the value of the property now held by him is as follows

amounting in the whole to Three hundred and four dollars and further that from the effect of his wound and infirmities he is at times unable to get his fire wood without the assistance of his neighbors. Sworn to and declared on the 4th day of Novr 1823 in Open Court

[The pension was restored on 5 Jan 1827, but he evidently did not receive the news before 5 Feb 1827, when he made another similar application with the following schedule of property.]

That since the exhibition of my first schedule the following changes have been made in my property 1 tract of land 136 acres no change, 1 horse no change

3 Cows and two yearlings all sold but 1 Cow to buy provisions 9 sheep sold for the same purpose as above 1 plough & harness sold for the same purpose 4 hoes and one axe 1 cart the hoes and axe sold for the same purpose as above 1 sow and six shoats not sold

Sworn to and subscribed in Open Court John X [his mark] Etherington

## NOTE:

The file contains an undated petition for the restoration of the pension of John Etherington, which was signed by 87 or his neighbors.

On 24 April 1841 Susan Etherington, 67, applied for a pension stating that she married John Etherington early in 1781, as estimated from the birth of her oldest child, Benjamin, born on 6 Jan 1782, and that her husband died "the last of 1830 or the first of 31." On 9 June 1841 Susan Etherington added that "she was married in at the County of Culpepper [sic: Culpeper] at the house of her sister (who was then married to the Brother of her deceased husband)" shortly after he returned from service, and that he afterwards returned to service.

The file contains an original family record on blank spaces of a New Testament, listing the births of children Benjamin, John, Henry, James, and Frances. In the transcription below, \* indicates a tear in the paper. One page of mostly scribbling is inscribed "Benjamin Eatherton his testament June 6 1786." In response to a query from the Pension Office for the address to which the Bible should be returned, the Postmaster of Mt Pleasant in Spotsylvania County stated that "there is a grand son of John Edington near this place by the name of John B Edington the son of Bengaman Edington."
