[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina Orange County

On this the Fifth day of August in the year while Lord 1844 came Mary Pearson before me Noah Trice one of the acting Justices of the peace for said County and made the following declaration on oath in order to obtain a pension by the several acts of Congress passed on the 7th of July 1838 the 3rd of March 1843 and the 17th of June 1844 and after being sworn doth declare on her oath that she is the widow of Paris Pearson who was a soldier in the revolution war and that he entered the service in the County and State aforesaid in a five months tower [sic tour] to the State of South Carolina and Georgia against the British and Tories commanded by Captain Lewis Bledsoe<sup>1</sup> and under the Control of General Ashe [John Ashe] and Colonel Caswell [Richard Caswell] and after he returned home from the five months tower, he again entered the service and served a three months tower in a Horse Company and was in the battle at Lindley's Mill<sup>2</sup> under the control of General Butler [John Butler] and commanded by Captain Matthew McCullers and she further says on oath that she was married to her husband Paris Pearson in the County of Wake and State aforesaid in the year 1785 and some years after that he emigrated to the County of Orange where she has resided ever since and the said Paris Pearson died in the year 1832 and he was 71 years of age when he departed this life and she further deposeth and says that she herself is now 75 years of age and very infirm and that her Maiden name was Mary Gilmore and she further says that she nor her husband Paris Pearson never was placed on the pension list of this or any State or territory and that she relinquishes all claim to a pension whatsoever except the present and she further says the reason that she has delayed affording her claim until this time was that she did not know that she could procure any evidence.

State of North Carolina Johnston County

On this the 21st day of August in the year 1844 came James Stephenson<sup>3</sup> personally before me Amos Coats one of the acting Justices of the Peace in and for the County aforesaid and after being duly sworn deposeth and saith that he is now eighty-five years of age and that he was born in the State of Virginia and his father emigrated to the County and State aforesaid when he was about seven years of age and that he has made said County his home ever since and he further says on oath that he was well acquainted with Paris Pearson who married Mary Gilmore and that the said Paris Pearson was a soldier of the revolution war and that he was drafted in the County of Wake and served a five months tower in the State of South Carolina and Georgia against the British and Tories and the said James Stephenson fur [sic, further] says on oath that he was there and served in the same Regiment with the said Paris Pearson under the control of General Ashe and [line of text obscured]

[Veteran's widow was pensioned at the rate of \$26.66 per annum commencing March 4, 1836, for her husband service as a private in the North Carolina militia.]
