Pension application of John Potts W4767 Susannah f76VA
Transcribed by Will Graves 11/8/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

The Deposition of John Potts of the County of Jefferson and State of Ohio –

Sheweth – This deponent entered the service of his country in the Army of the Revolution on the 7th day of March in the year of our Lord 1777 enlisting for the Term of three years in the Company of Captain William Smith of the 11th Regiment in the Virginia Line – commanded by Colonel Daniel Morgan – That he served in that Company, Regiment and Line in the Battles of Brandy-wine [Brandywine, September 11, 1777], Germantown [October 4, 1777], Brunswick [June 22, 1777] and Somerset Court House [January 20, 1777] – He will was marched after the last to Trenton New Jersey, where on the 7th day of March 1780 he was honorably discharged having completed the full Term of his Enlistment. That he kept it (his discharge) about two years, when he was induced to give it to his Colonel for the purpose of obtaining Virginia Military Lands. That the Colonel has since died and it is impossible for this deponent to obtain the discharge. He further deposes and says that from the very reduced and necessitous state of his circumstances in life he is in great need of the assistance of the United States for support, that he never has received any pension or compensation in [indecipherable word] thereof for these services from the United States – & he doth hereby renounce all claim to any pension

State of Ohio Jefferson County: SS

On this 27th day of June 1818 before me the subscriber, President Judge of the Courts of Common Pleas of the 5th Circuit in the State of Ohio personally appeared John Potts aged sixtyseven years resident in said County of Jefferson, who being by me duly sworn, doth on oath, make the following declaration in order to obtain the provisions made by the late act of Congress entitled "An Act to provide for certain persons engaged in the land and Naval service of the United States in the Revolutionary War" – That he the said John Potts, enlisted for the term of three years on the 7th day of March in the year 1777 in the State of Virginia, as a private in the company of Captain William Smith of the eleventh Virginia Regiment commanded by Colonel Daniel Morgan, then at Leesburg in said State – That he continued in the service of the United States in the company, Regiment and Line until his term of service having expired, he was honorably discharged from service at Trenton in the State of New Jersey by Captain Kirkpatrick - That he served in the battles of Brandywine, Germantown, Brunswick and Somerset Court House. That he had a written discharge which he gave his Colonel who never returned it to him, and who is long since dead. That he has no other evidence of his said services than what is hereto annexed – That he is in reduced circumstances, very aged and infirm, and stands in need of the assistance of his country for support. Declared, sworn to and subscribed before me the

day and year first above written by the said John Potts who expressly resigns all claim he may have to any pension from the United States.

Jonathan Potts¹ of Jefferson County Ohio being duly sworn, doth depose and say, that the facts set forth in the above written statement are to his certain knowledge of 4 mentioned immediately after his enlistment and served his whole time out & was discharged according to the above Statement – that he is in reduced circumstances & in need of the assistance of his country for support.

[f p. 10: On February 26, 1839 in Carroll County of Ohio, Susannah Potts, 76, widow of John Potts, filed for her pension as his widow under the 1838 act; that she married him in Berkeley County Virginia in the month of March but she does not recollect the day or year but knows it was before January one, 1794; that her husband died October 20, 1820 at his residence in Columbiana County Ohio. She signed her application with her mark.]

[f p. 65: copy of a marriage bond dated March 12, 1782 issued in Berkeley County Virginia to John Potts and John Sheeby, bondsmen, conditioned upon the marriage of John Potts to Susannah Hibbons.]

[f p. 12: On March 22, 1839 in Carroll County Ohio, Nathan Potts gave a deposition that he was intimately acquainted with John Potts late of Columbiana County Ohio; that he verily believes that said John Potts was married in Berkeley County Virginia to Susannah Hibbens²; that he, deponent, resided in their family for more than 6 months after the birth of their first child and afterwards for years in a settlement in Weston Pennsylvania; that John Potts told him, the deponent, that he enlisted under Ensign Thomas Thomas under Captain Smith, first Lieutenant Isaiah Marks; that John Potts was later in a company commanded by a Lieutenant Townsend and under Lieutenant David Williams and Lieutenant Isaac Brown late of Hanover Columbiana County aforesaid. The witness signed his affidavit with his mark.]

[Facts in file: the widow was living with her son Thomas in Washington Township Carroll County Ohio when she executed her application dated February 26, 1839; in 1843 she was living in Fox Township Carroll County Ohio with his son not named. She was still living in 1851; the oldest child of the veteran and his wife, a daughter, not named, was born February 1783 and was dead in 1839. This 2nd child, Jonathan, was born in the fall of 1785, their youngest children Thomas and David, were born March 20, 1807.]

[Veteran was pensioned at the rate of \$8 per month commencing April 28, 1818, for service as a private in the Virginia Continental line. His widow was pensioned at the rate of \$96 per annum commencing July one, 1848.]
