Pension application of Michael Briton (Britton) W4905 Nancy fn37NC Transcribed by Will Graves 10/5/10

State of North Carolina Hertford County: SS

On this 26th day of August 1833 personally appeared in open Court before the Court of Pleas and Quarter Sessions in the County of Hertford State aforesaid Michael Briton aged seventy years and made oath according to law to the following statement to obtain the benefit of the Act of Congress passed June 7th 1832;

That he was drafted as a private in the year 1780 he believes, the month he cannot recollect, in Captain Lewis Brown's North Carolina militia for the space of three months; he marched from home (Hertford County) to Charleston South Carolina under the command of said Captain Brown, the North Carolina Troops were commanded by General Caswell, just before they reached Charleston the Enemy had taken that City, and our troops retreated. After serving his tour out he returned home – receiving an Honorable authorize [sic, authorization] from his officers, but which is lost.

That he was drafted a second time some 2 or 3 months afterwards in Captain Perry's Company as a private for three months, Hertford Regiment Colonel Wynns, rendezvoused at Pottacacy Creek [sic, Potecasi Creek], & there and at other places in the County he discharged faithfully his duty as a soldier until Discharged after his tour had ended.

His discharge in this case is also lost, he has no documentary evidence to prove his service but conceives the testimony of Nathl. Saunder sufficient to sustain his claim you will you will and he relinquishes hereby every claim whatever to a pension or annuity except the present, & declares that his name is not on the pension Roll of the Agency of any State.

- 1. He was born in Hertford County North Carolina in the year 1763 –
- 2. He has no record of his age
- 3. He was living in Hertford County when called into the service. He has lived in said County ever since the war, and is still a resident of the same
- 4. I was drafted each time
- 5. He served with Captain Abner Perry, Colonel George Wynns, General Caswell –
- 6. He received a discharge but it is lost
- 7. He refers the Department to Watson Lewis, David V. Askew & Starkey Sharp as persons who will testify as to believe in my services in the Revolution and to my character as a person of veracity.

State of North Carolina Hertford County: Court of Pleas & Order Sessions May Term 1833

Nathaniel Saunders¹ aged seventy-six years appeared in open Court and made oath that he is a Revolutionary Pensioner now on the rolls of the War Department that he is well acquainted with Michael Briton for more than sixty years, that he knows said Britain served three months as a private in Captain Brown's company North Carolina Troops commanded by General Caswell at the time Charleston was taken by the British – the year, this deponent being illiterate, cannot remember. This deponent recollects that in another period said Briton was drafted for three months in Captain Brown's company rendezvoused at Pottacacy Creek this was the same year that Cornwallis was taken at Little York. The deponent further saith that said Briton bore the reputation of a true soldier.
