Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of North Carolina, Johnston County

On this the 6th day of January 1845 personally appeared before the Subscriber one of the Acting Justices of the Peace in and for said County Mrs. Mary Gurley resident of Johnston County aged 91 years who being first duly sworn according to law, doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed the 4th day of July 1836.

That she is the widow of Joseph Gurley who was a soldier of the Revolutionary War, that her husband the said Joseph Gurley enlisted in the Army of the Revolution of the United States in the month of September 1781 for twelve months and served the time out and then Enlisted for during the War and Served fourteen months more – When the war ended he enlisted under Captain Raiford [Robert Raiford]. She cannot at this time recollect under what other officers he served. She distinctly recollects of hearing him say he served in Raiford's Company and she knows he will was gone from home two years and two months. She further declares that she was married to her deceased husband the said Joseph Gurley in the month of January 1780 in the County of Johnston State of North Carolina by Henry Rains Esquire and that her maiden name was Mary Carter and that her husband the aforesaid Joseph Gurley died on the 10th day of March 1828, and that she has remained a widow ever since his death.

This affiant Testifies and says

That he was well acquainted with Joseph Gurley deceased late of Johnston County who was a private Soldier during the Revolutionary War that he served with him from Virginia line

through North Carolina to South Carolina he belonged to Captain Raiford's Company and I served with him some over 2 years I think 2 years and 2 months as we were both Regular Soldiers, I know I served with him in the year 1781 and 1782 I have a perfect Recollection of having served with him.

On this 24th day of January 1845 personally appeared before the Subscriber a Justice of the Peace in and for said County Jesse Green² aged 84 years a pensioner as a Soldier of the Revolutionary War who being duly sworn according to law doth on his oath make the following affidavit

This affiant testifies and says

That he was well acquainted with Joseph Gurley deceased late of Johnston County and with Mrs. Mary Gurley his widow who is now applying for a pension I know that Joseph Gurley served in the Revolutionary War under Captain Raiford's company in the year 1781 and 1782 I have a perfect recollection of being with him at Halifax Tarboro New Bern and Trent and Wilmington we were from the same County he was a Regular and I was a militia man I know he was gone from home more than 2 years.
