Pension Application of Moses Fontaine (Fountain) W5076 Transcribed and annotated by C. Leon Harris

On this the 19th day of September 1844 personally appeared before me Randolph V Barksdale a Justice of the peace in and for the County aforesaid Elizabeth Fontaine a resident of Virginia in the County of Pittsylvania aged eighty eight years who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provisions made by the act of Congress past July the 4th 1836 That she is the widow of Moses Fontaine who was a Captain in the Army of the Revolution that he was drafted or volunteered in the County of Halifax Virginia in the latter part of the spring or the first of the summer of 1780 (as well as she now recollects) and was marched to the South and was in the engagement of Gates's defeat [defeat of Gen. Horatio Gates at Camden SC, 16 Aug 1780] that he was attached to the Regiment Commanded by Col Coles as well as she now recollects, She further state that he was out in the service for six months and was honourably discharged she further states that she has frequently seen his discharge which is now lost or mislaid She further declares that she was married to the said Moses Fontaine on the 10th of July 1773 That her husband the aforesaid Moses Fontaine died on the 3rd day of December 1801 and that she has remained a widow ever since that period as will more fully appear by reference to the proof Elizabeth herXmark Fontaine hereto annexed.

County of Halifax } I William Whitt a Revolutionary Pensioner [S7870] of the United States under the act of Congress of the 7th of June 1832 certify I was in the army of the Revolution with Capt Mosses Fontain (the deceased husband of Elizabeth Fontain who is now applying for a a Pension) he was drafted for six months in 1780, I think, My Father was drafted for the same service and I substituted for my father and was placed under the command of Capt Mosses Fontain (who was from this county Halifax) we was then marched to Hillsborough [NC] where we joined the mane army and was marched to the south and was in an engangement at Gatess defeat after the expiration of the six months service Capt Fontain was discharged and returned home I certify he afterwards removed to Pittsylvania county where I have been informed he died

I, William Holt, Clerk of the County Court of said County in the state aforesaid certify that at a Court held for the said County the 21st day of August 1777, I find among others, the following orders made for the recommendation of Militia Officers in order to be commissioned, Towit:

"Joseph Gill as Second Lieutenant to Captain Moses Fontaine's Company"

"Jacob Faulkner as ensign to said Company"

I further certify that, I have carefully examined the records of my Office prior to the year 1781 and find no evidence that "Captain Moses Fontaine" resigned his commission as an Officer of the Militia, up to that time. In testimony of all which, I hereunto subscribe my name and affix the seal of the said County at my Office this the 28th day of November AD 1844. Wm Holt
