Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

On this 15th day of June 1843, personally appeared before the Circuit Superior Court of Law and Chancery for the County of Henrico and City of Richmond in the common law side, Nancy Lord, a resident of the said County of Henrico, aged about seventy-six years and four months, who being duly sworn according to law, doth on her oath make the following declaration, in order to obtain the benefit of the act of Congress passed July 7, 1838, entitled "an act granting half pay and pensions to certain widows," to wit –

That she is the widow of Robinson Lord late of the said County of Henrico deceased, who, as this affiant has always understood and verily believes, was a native of the County of King William, Virginia, and while resident in his said native County, enlisted as a private soldier in Captain Christopher Roane's company of Artillery in the Continental or State line of Virginia, and served in that rank under that officer more than two years; that he was at the battle of Camden, and in the said service, on the 16th day of August 1780, and was there taken prisoner.

That she was married to the said Robinson Lord on the 5th day of November 1785 – that her husband the said Robinson Lord died in the County of Henrico, where he had resided for many years, on the 15th day of July 1819 – that she was not married to him prior to his leaving the service, but the marriage took place previous to the first day of January 1794, to wit, on the day above stated

[p 8: copy of a marriage bond dated November 4, 1785 issued in King William County Virginia to Robinson Lord & George Thompson conditioned upon the marriage of Robinson Lord to Nancy Deane daughter of Sarah Deane.]

[p 12: testimony given that the family record in the handwriting of the veteran indicates that he was married to his wife Nancy on the 5th day of November 1785 and that Sallie Williams Lord was born November 3rd 1786 and that the veteran died July 15, 1819 "in the 55th year of his age"]

[p 25: Court finding that Nancy Lord widow of Robinson Lord died July 30, 1843 leaving Frances D King (wife of Isham A. King) of the County of Henrico and State of Virginia her only

surviving child.]
