[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

South Carolina Pickens District: SS

On this the First day of June 1846 personally appeared before me William D. Steele Judge of the Court of Ordinary for said District, Mrs. Mary Masters a resident of the State and District aforesaid aged 70 Years, who being first duly sworn according to law doth on her oath make the following Declaration in order to obtain the benefit of the provisions made by the act of Congress passed July 7th 1838 and the several acts in continuation thereof that she is the widow of Notly Masters who was a private in the war of the Revolution and entered the service in South Carolina and was at the Battle at Musgrove's Mills,² and she thinks he was under General Cazy [sic, Lt. Col. Levi Casey] and recollects to have heard her husband speak of being in several battles. She further states she was married to Notly Masters on the 30th of July 1793 and he deceased February the 12th 1819 -- and she further states that she was married to Notly Masters in Pendleton District so called at that time but now Anderson District South Carolina and that she was married by William Bennett a Baptist preacher and has remained a widow ever since the death of her said Husband Spell that Notly Masters.

[p 28: Rachel Anderson, 69 or 70, of Pickens District SC testified on May 26, 1846, that she was present at the marriage of Notly Masters to Mary Hembree in the somer [summer] of 1793. She signed her affidavit with her mark.]

[p 29: Benjamin Dickson, Sr. of Anderson District, SC testified on May 23, 1846, that he and Rachel Anderson were present at the marriage of Notley Masters to Mary Hembree at Pickenses Mill on Rockey River Pendleton District and that they waited on the groom at that ceremony.

State of South Carolina Pickens District:

Before me, personally appeared the Revent [sic, Reverend] Benjamin Nabors [sic, Benjamin Neighbors]³ and mad [made] oath and upon oath Saith that him selfe and Notley Masters turned out volunteers Before the Reduction of Charlestown under Capt Thomas Doggins [sic, Thomas Dugan] and leftenant [sic, Lieutenant] Levy Casey [sic, Levi Casey] and Was in Surves [service] three mont [months] with Notley Masters and was Personly [personally] acquainted with Notley Masters and he Said he new [knew] nothing more of him untell [until] peace was mad [made] and after peace was mad [made] he came Back and Shinggles my Brauthers havs [sic, shingled my brother's house?] and I new [knew] him for some several year [years] and he move [moved] away out of the sittlement [settlement]. I Benjamin Nabors [am] astate [a state] Pensioner Doe [do] Surtify [Certify] this to be a true fact. Sworn to and subscribed before made this the 25th day of December 1846 S/R. T. Stewart, M. P. D.

[p 51: On January 28, 1850 in Pickens District South Carolina John Anderson, aged 80, gave testimony that he was acquainted with Mary Hembree in 1792 and also with Notley Masters; that they were married July 30th, 1793 by William Bennett a Baptist Preacher; that affiant got married in November 1795 and lived near Masters in his wife until they had 3 children, Charlotte, Martha and Washington; affiant remembers that the affiants eldest daughter was married in 12 months after affiant was married; that affiant was living in Newberry District South Carolina within about 18 miles of the veteran and his wife.]

[p 8: On May 4, 1855 in Anderson District South Carolina, the widow applied for her bounty land entitlement as the widow of a revolutionary war soldier. She signed this document with her mark.]

[p 11: On December 6th, 1867 in Milton County Georgia, Charlotte Drennan, 56, filed a claim

stating that she is the daughter and heir of Mary Masters (widow of Notly Masters); that her mother died in Milton County Georgia at the residence of Joseph W. Drennan on the 11th day of June 1865; that her mother's children were by the names of William Masters, James Masters, Zackias Masters and Charlotte Drennan, only surviving children -- that William, James and Zackias Masters did take up arms and aided in the late rebellion but that claimant was loyal to the US government and seeks restoration to the pension list.

[Facts in file: Veteran and his wife had a daughter named Patsy who was born in 1794 according to Rachel Anderson (p 33); in addition they had children named Charlotte, Martha [could be the same as Patsy?] and Washington, according to John Anderson, 84, of Pickens District SC. The Reverend Edward Hembree gave testimony in Pickens District South Carolina as to the character of Rachel Anderson and her entitlement to full faith and credit.]

[Veteran's widow was pensioned at the rate of \$26 per annum commencing March 4th, 1836 based upon her husband service as a private in the South Carolina militia.]
