[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

For the purpose of obtaining the benefits of an act entitled "An act for the relief of certain Surviving Officers and Soldiers of the Army of the Revolution" approved on the 15th of May 1828 I Thomas Minor of the County of Spotsylvania in the State of Virginia do hereby declare that I was in Officer in the Continental Line of the Army of the Revolution, and served as such until I was reduced under the Act of 3rd & 31st of October 1780 and in consequence also of the time for which my Company was enlisted, having expired when I was appointed aid to General Stevens [Edward Stevens] in which capacity I served at the battle of York Town – at which period I was a Captain and when in actual command of my company belonged to the second Regiment of the Virginia line. –

The reason why I never received the Certificates or Commutation is that then I was in different circumstances and not in need of any bounty from the Govt and I never applied for the same knowing the fact that at that time, they were not worth the trouble of procuring. I always knew that I was entitled to such bounty because I held myself ready at any time to repair to whatever post I might have been ordered; consequently and virtually was in service until the end of the war when my services were known to me not to be further required, then and not till then. I consider myself as free from my engagement to serve during the War. — Witness my hand, this the 18th day of January 1830.

Witness my hand this the 8th day of January 1830.




Thomas Minor was and Officer in the Revolutionary war, holding the rate of Captain, and acting on Continental duty, & belonged to General Muhlenberg's Brigade. I enlisted under said Minor as a soldier in March 1777, and was under his command 3 years & that we were engaged in the battle at Monmouth.

Given under my hand and & seal this 21st day of December 1829.



[p 15: On May 6, 1839 in Spotsylvania County Virginia, Hubbard T Minor of Spotsylvania County Virginia made a claim under the 1832 act stating that he is one of the sons of Thomas Minor who was a revolutionary war pensioner and whose representatives received half pay under the act of Congress of July 5, 1832 on account of the services of Thomas Minor as an officer in the revolution and is; that his father died July 21, 1834; and his mother died December 7, 1836 and that the following all the names and residences of his father's children viz.: Melinda Buckner, wife of George M Buckner of Missouri, Sarah Ann Lewis, wife of Addison M. Lewis of the state of Kentucky, Elizabeth Jackson, wife of William Jackson, James Minor, Jefferson Minor, Hubbard T. Minor [born August 1, 1796], Alice T. Minor and Ann Maria Scott wife of Frances W Scott all of the state of Virginia; In addition to the foregoing the late Thomas Minor had one other daughter named Patsey T. who intermarried with Henry T. Chivis, the said Patsey died in the lifetime of the said Thomas, leaving the following 9 children viz.: Thomas M. Chivis of Missouri, John M. Chivis, Sarah Halyard whose husband left her, since which she has obtained a divorce – Elizabeth wife of John Spencer, Ann H. wife of Benton R. Hamm and Mary E. wife of Alfred Clark all of the state of Kentucky.]

[p 11: On December 20, 1847 in Essex County Virginia, Jefferson Minor a resident of said County filed a claim seeking the benefit of the act of 1836 stating that he is one of the surviving children of Elizabeth Minor, deceased, widow of Thomas Minor of Spotsylvania County; that his mother Elizabeth Minor was married to the said Thomas Minor before the expiration of his term of service but this deponent cannot state the precise time of their marriage as the Bible record thereof was carried to the State of Kentucky by some member of his Father's family; they were however married before the Siege of York in 1781; that his parents were married in Caroline County Virginia in the Rappahannock Church in said County; that his father Thomas Minor died July 21, 1834 and his mother Elizabeth Minor died December 7th, 1836.



[p 18: facts in file, soldier married in 1780 in Caroline County Virginia Elizabeth, daughter of Colonel James Taylor. In addition to the children named in the application of Hubbard T. Minor, his parents had the following children who evidently died without heirs prior to their father's death: Nancy, Lucy, Thomas and John (twins)

To the Executive of Virginia

Your Petitioner Thomas Minor, of the County of Spotsylvania hereby Sheweth, that he was an Officer of the Virginia Continental line of the Army of the Revolution having entered the service first in a Volunteer Company & afterwards in the Minute Service in the spring 1775; was in actual service until after the battle of Yorktown, & remained in service until the close of the War, not having resigned, been superseded or cashiered. Your Petitioner has never heretofore felt in need of the aid of the Government, and never asked for the Land bounty to which he considered himself justly entitled, the justice of which can be abundantly proven. He became a supernumerary Officer after the battle of Yorktown, his actual services having terminated at that place, but held himself in readiness to serve his Country whenever called upon, & never until after the close of the war when he found his services no longer required, that he considered himself as freed from his engagements to serve throughout the War; His Commission as a Captain, he retained until long after the war, but never in former days intending to call upon the Government for any Bounty, it has been misplaced or destroyed; the fact however of his having served in that capacity with a regular Commission can be satisfactorily established. Your Petitioner believes that he is entitled to Land Bounty for eight years services, and asks that it may be allowed to him, and feels himself in duty bound to pray &c
