State of North Carolina County of Rockingham

On this the 3rd day of March A.D. 1852 personally appeared before me a justice of the peace within & for the County & State aforesaid Mrs. Susanah Oliver aged eighty-eight years, a resident of the County of Rockingham in the State of North Carolina who being duly sworn according to law declares that she is the widow of James Oliver deceased who was a private in the company commanded by Captain Josiah Gates, or Captain George Cook in the Regiment of the North Carolina Militia commanded by Colonel James Martin in the Revolutionary war of the United States of America with Great Britain. That her said husband was drafted in the County of Rockingham¹ on or about the last of the year 1780 or the first of the year 1781 for the term of about six months & continued in active service in said war for the term of about six months & was honorably discharged, she thinks in the County of Guilford NC.

She further states that she was married to the said James Oliver in the County of Rockingham NC in the year 1782 by one George Peay a justice of the peace in and for said County. That her name before her said marriage was Lemons and that her said husband died at his residence on the 8th day of February 1840 and that she is still a widow –

She states that her husband never applied for or received any pension for his services, from the fact as he stated to her that he was able to live without it & that he was no scholar & that it would be attended with a good deal of trouble.

She makes this declaration for the purpose of obtaining the pension to which she may be entitled under the act passed by Congress the 15th day of May 1828, The act passed the 7th day of June 1832, The act passed September 28th 1850 and any other act passed by Congress giving pensions for services rendered in the Revolutionary War with Great Britain.

Supplementary Declaration

State of North Carolina Rockingham County: two with

On this 12th day of May in the year of our Lord 1852, personally appeared before the subscriber a justice of the peace, Mrs. Susannah Oliver, a resident of Rockingham County in the state of North Carolina aged eighty-six years, who being first duly sworn, according to law, doth, on her oath, make the following declaration; Supplementary and to correct one error which she believes to have been made in her Original declaration already on file at the Pension office, and bearing date 3rd day of March 1852, in order to obtain the benefit of the provision made by the act of Congress, passed July 7th 1838 entitled an act granting half pay and pensions to certain widows. That she is the widow of James Oliver, who was a private in the North Carolina Militia, in the Revolutionary War, in a company commanded she believes by Captain Josiah Gates, or Captain George Cook, but he may have served in both Companies and under both those captains, in Colonel James Martin's Regiment. She further states that her husband may have served in other Companies and under other captains, but at this remote period and owing to her great age, if such was the case she does not now recollected. She has been led to believe however since making her first declaration that her said husband served at the least a full year and perhaps longer, and she therefore wishes hereby to amend her Original declaration as to give her the benefit of all the time during which her said husband served, which she is induced to believe was a year at the least if not longer. She says as to her original declaration that her husband entered on one of his towers [tours] of service in Rockingham County in the State of North Carolina, about the last of the year 1780 or first of 1781. She also states that he may have served, and probably did serve other tours than the one above. She states that her husband was in the service when the battle of Guilford was fought. She also states that she was married to her said husband in the County of Rockingham in the State of North Carolina by one George Peay a justice of the peace in the year 1782 that her name before to her marriage was Lemons, and that her said husband died at his residence on the eighth day of February 1840 and that she is still a widow.

[fn p. 6: On May 27, 1852 in Rockingham County North Carolina, Alexander Wall gave testimony that he was acquainted with James Oliver and his wife Susannah for 40 years; that they lived together as man and wife and raised several children to wit: John, Samuel, Mary, Susanah, Elizabeth, Nancy and Sarough [sic].]

[fn p. 9: on March three, 1852, in Rockingham County North Carolina, Peter Oliver, 82, the brother of James Oliver gave testimony that his brother was drafted he thinks in the year 1782 serve against Great Britain in a company he thinks commanded by Captain Josiah Gates

belonging to the Regiment of North Carolina militia commanded by James Martin; that he was present when his brother entered the service; that his brother about six months; that he has often heard old revolutionary soldiers speak of being in the service as his brother; that his brother was in the service at the time of the battle of Guilford and was discharged in Guilford County, he thinks; that about the year 1782 his brother married Susanna Lemons. Peter Oliver signed with his mark.]

[fn p. 27: certificate dated June 14, 1852 from the North Carolina Comptroller General showing payments made to one James Oliver for military service during the revolution.]

[Veteran's widow was awarded the pension due him at the rate of \$40 per annum commencing March 4th, 1831 and ending February 8, 1840, the date of his death,; in addition, commencing March 4th, 1848, she was awarded a pension in her own right at the rate of \$40 per annum.]
