Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Virginia County of Halifax

On this the 20th day of September 1839 personally appeared before me James M. Chappell an acting Justice of the Peace in and for the County aforesaid Drusilla Pate who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July the 7th 1838 entitled an Act granting half pay and Pensions to certain Widows, That she is the widow of Matthew Pate who was a private Soldier in the Virginia State Line Army of the revolution the affiant states that her Husband Matthew Pate deceased resided in the County of Halifax State of Virginia when he enlisted a private Soldier, She further states that she is not able to recollect the precise date of her Husband's enlistment but supposes it was about the year 1779; nor the various movements of the Army at the time he was in the service as he was a long time in the service and was necessarily marched to various places, She states also that she has often heard her deceased Husband mentioned the movements of the Army at the time he was in the service but she is unable to recollect the particulars, but would refer to the Hon. Department to the Rolls of the Virginia State line Army of the revolution for a full knowledge of the services of her deceased Husband Matthew Pate, She further states that she was married to the said Matthew Pate deceased on the 9th day of December 1784 in the year 1784, that her Husband the aforesaid Matthew Pate died on the 2nd day of November 1828, That she was not married to him prior to his leaving the service but the marriage took place previous to the first day of January 1794 viz. at the time above stated.

[f p. 7: On September 20, 1839 in Halifax County Virginia, Samuel Pate testified that Matthew Pate died November 2, 1828 and that his widow Drusilla Pate has never remarried. The relationship, if any, of Samuel Pate to the veteran is not stated.

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia State Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 5th day of June 1783, in the name of Matthew Pate, as a Soldier of Infantry for £66.16.10, which Certificate appears to have been delivered to himself and was given for services prior to the 1st January 1782.

Given under my hand, at the Auditor's Office, Richmond, this 3rd day of August 1839.
