[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

On this 3rd day of June 1844 personally appeared before me Elihu S. Barclay, one of the Justices of the Inferior Court in and for said County Sarah Pardue a resident of the 409th district Morgan's Militia in the County of Habersham and State of Georgia aged Seventy-One years who being first duly sworn according to law, doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July the 4th 1836 (or any other act or acts that may imbrace the services hereto annexed & hereinafter named) that she is the Widow of Lilliston Pardue a revolutionary Soldier, who was a Sergeant in the Militia in the State of South Carolina for the term of at least six months, as appears from a certified copy from the Indent Book T. from the Executive department of the State of South Carolina as per Colonel Anderson [Robert Anderson] under whom he served. She also says that according to the traditionary evidence he the said Lilliston Pardue was enlisted and mustered into Service in Savannah in the State of Georgia under McIntosh [probably Lachlan McIntosh] and served for a term of eighteen months in the State of Georgia and Territory of Florida and was engaged three successive Sundays in fighting the Indians which latter Service she hopes will be readily found on record at the war department. She further declares that she was married to the said Lilliston Pardue on the 5th day of June in the year 1793, that her husband the aforesaid Lilliston Pardue died on the 7th day of February 1807, and that she has remained a widow ever since that period, and raised six children, that were under sixteen years of age at the death of their father the said Lilliston Pardue as will more fully appear by reference to the proof hereto annexed. She declares that she is now a cripple and unable to support herself without the help of the Government.

Personally came before me James Ritchie an acting Magistrate in and for said District Nancy Flinn who being first duly sworn according to law deposeth and saith on her oath that the Original family record of the father of Sarah Pardue has long since been lost and that it nor any other direct documentary evidence of the marriage of Sarah Pardue is known to exist and that the reference to the family records in her affidavit of May 1844 was to that of her own (Nancy

Flinn's) family record: to wit. From the Birth of one of her children which occurred in September the year after said marriage of Sarah Pardue in June the year previous to the birth year of said child. She further states that she (Nancy Flinn) knows she will have been married 52 years to William Flinn in next August 1845 and that she was married in August the same year that Sarah Pardue was married in June. She further says that from the above circumstances she knows that the marriage of Sarah West (Pardue) with Lilliston Pardue took place on the 5th day of June 1793 in the State of South Carolina Edgefield District Before and By Benjamin Harry Baptist Minister of the Gospel and that she was present at and saw the marriage. Sworn to and subscribed before me this July the 18th day 1845.

[p 24: Elizabeth Clagg gave testimony on May 2, 1846 in Abbeville District South Carolina that she was present at the marriage of the veteran to Sarah, now his widow, in Edgefield District South Carolina when the affiant was between 10 and 12 years old and is now and 64 or 65; that she road to the wedding with her father (not named).

[p 27: On February 16, 1846 in Habersham County Georgia, Smith Jones, 74, gave testimony that he was present at the marriage of the veteran and Sarah West in Edgefield District on June 5, 1793.



[p 15: in a filing in 1846 in Habersham County Georgia, Sarah Pardue states that she has no family record but that she can date her marriage by the age of her first child who is now 52 years old and was born the next succeeding March following her marriage.]

[p 6: On March 24, 1855 in Habersham County Georgia, Sarah Pardue, 81, filed for her bounty land entitlement as the widow of Lilliston Pardue; in this application she states that she was married to her husband in Edgefield District South Carolina by Benjamin Harry, a Baptist minister; that her maiden name was Sarah West.]

[Veteran's widow was pensioned at the rate of \$36.17 per annum for her husband service as a Sergeant in the South Carolina militia.]
