Pension application of Thomas Arnold W5640 Transcribed by Will Graves Mary Arnold f94SC rev'd 5/7/10 & 7/31/14

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Alabama, Autoga [sic, Autauga] County

Personally came before me on this 16th day of April Eighteen hundred and thirty three in open Court of the Circuit Court of Autauga County and State of Alabama now sitting, Thomas Arnold, a resident of Autauga County, in the State of Alabama aged seventy years, who being first duly sworn according to Law, doth on his oath, make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named officers, and served as herein stated.

That he entered the service of the United States as a volunteer in the State of South Carolina, under Capt. John Ridgeway in the year 1779, in the District of Ninety-Six, that he was marched from thence under the command of Capt. John Ridgeway to the State of North Carolina, Rutherford County where he joined the Army of Genl Morgan [Daniel Morgan], a short distance from the Cowpens, that he was at the battle of the Cowpens² but was unable to fight in consequence of a wound he had previously received in a skirmish at Hammon's old Store [sic, Hammond's Old Store³] in the State of South Carolina, District of ninety six under the command of Col. William Sumpter. ⁴ That he continued in the service in North Carolina about three months during which time he was marched through different parts of the state, in skirmishing expeditions. That after the expiration of his then stay in North Carolina, he was marched back to South Carolina, Ninety Six district, by Capt. John Ridgeway. That he continued under his command until he was killed by William Cunningham on Dirty [?] Creek in the District of Ninety Six. By reason of whose death he was unable to get a discharge from the service. That he served as a volunteer upwards of nine months. That he served with Col. Sumpter [Thomas Sumter], Genl Morgan, Col. Washington, Col. Elijah Clark [Elijah Clarke] and Lieut Walter Garner and others whose names he cannot remember. That he has no documentary evidence and that he knows of no

Thomas Sumter was not present at Hammond's Old Store because he was still recovering from the severe wounded he suffered at Blackstock's Plantation the month before. Also, by the date of the engagement at Hammond's Old Store, Sumter had been promoted to the rank of Brigadier General of the SC militia. The reference, therefore, is most likely to Col. William Washington who was the commanding officer at the engagement at Hammond's Old Store.

Int. 1. When & in what year was you born?

Answer. I was born in the State of Virginia Buckingham County in the year 1763.

Int. 2. Have you any record of your age; and if so where is it?

Ans. I have no record of my age, it is lost? [sic]

Int. 3. Where were you living when called into service; where have you lived since the revolutionary war & where do you now live?

Ans. I lived in the State of South Carolina when called into service, since that time I have lived in the State of Kentucky Logan County & am now living in the State of Alabama Autauga County? [sic]

Int. 4. How were you called into service; were you drafted, did you volunteer or were you a Substitute? & if a substitute for whom?

Ans. I was a volunteer during the whole of my service.

Int. 5. State the names of some of the regular officers who were with the Troops where you served, such Continental & militia regiments as you can recollect, and the general circumstances of your Service?

Ans. The names of the officers with whom I served were General Morgan, Colonel Washington, Colonel William Sumpter, Colonel Andrew Pickens, Colonel Eli Clark, the general circumstances of my service are above related.

Int. 6. Did you ever receive a discharge from the Service? If so by whom was it given and what has become of it?

Ans. I never received a discharge.

Int. 7. State the names of persons to whom you are known in your present neighborhood & who can testify as to your character for veracity & their belief of your services as a soldier of the revolution?

Ans. I am well acquainted with Eli Terry, Samuel Simmons, Robert Brodnax, Thomas Hogg & Redden Jones.

State of Alabama Lowndes County: Personally appeared before me A J Rutherford a Justice of the Peace for the State and County aforesaid Thomas Hamilton⁵ at the prayer of Thomas Arnold, who deposeth & saith that Thomas Arnold aforesaid commenced service in the Revolutionary war in the month of March in the year 1783 being near the close of the

war; as a volunteer under Colonel Casey & Captain George Martin, as a private & continued in the service for 12 months & was discharged in skirmishes against the outlying Tories in the Ninety Six district as then called into State of South Carolina this is a true and correct affidavit of Thomas Hamilton for the benefit of Thomas Arnold that he may obtain a pension. Taken by me this 8th day of March of the 1840.

State of Alabama Autauga County

On this 17th day of March 1840 personally appeared in open Court, before the Court of the County Court now sitting Thomas Arnold aged seventy-seven years, a resident of the State of Alabama and County of Autauga and on his oath makes the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832. That he entered the service of the United States under the following named officers and served as herein stated. That he entered the service as a volunteer as well as he remembers in the year 1779 under the command of Captain John Ridgway in the State of South Carolina in the district of Ninety Six. That he was principally engaged in scouting parties. That he was engaged in many skirmishes with the British and Tories. That he was in one engagement under the command of Colonel Elijah Clarke near the Long Cane⁶ in the District of Ninety Six State of South Carolina in which engagement Colonel Clarke was wounded in the shoulder. That he was in the battle of the Cowpens in the State of South Carolina under the command of General Daniel Morgan. That he well remembers the names of Colonel Washington and Colonel Pickens who ably supported General Morgan during the engagement. The deponent further declares that from the time of his in ring into service that he marched principally through South Carolina and North Carolina. That he served as a private soldier under the command of Captain John Ridgway eighteen months. That Captain John Ridgway was killed by a party of Tories under the Command of Colonel William Cunningham in the State of South Carolina Ninety Six District. That after the death of Captain John Ridgway he continued in the service under the command of Captain George Martin as a private for 12 months. That while under the command of Captain George Martin that he was engaged principally in ranging and scouting in the State of South Carolina. That Captain Martin's Company would occasionally unite with Captain Lewis Saxon's [Lewis Saxton's] Company & Colonel Casey [Levi Casey]. That while under the command of Captain Martin he was in no general Engagement. That he commenced service under the command of Captain Martin in the month of March 1783. That in consequence of the untimely death of Captain John Ridgway he never received any discharge from the service. This deponent further declares that during the time of the aforesaid service he was not engaged in any civil pursuit. This deponent further declares that by reason of the great lapse of time and old age and consequent loss of memory he cannot swear positively as to the precise time of his service but he is confident he served as a private soldier for the period of 2 years & 6 months.

I do hereby relinquish all and every claim whatever to a pension or annuity except the present and declare that my name is not on the pension roll of the agency of any State in the United States except Alabama.

[p 8: On January 3rd, 1845 in Dallas County Alabama, Mary Arnold filed for the arrearages due her deceased husband as a pensioner of the United States; she states that she now resides in Dallas County having resided there for 2 years last past and that prior thereto she had been a resident of Autauga County Alabama. She signed this document with her mark.]


[p 15: Of January 18, 1854 in Dallas County Alabama, Mary Arnold, 88, filed for a widow's pension under the 1844 and 1848 acts stating that she is the widow of Thomas Arnold a pensioner of the revolution for his service therein; that her husband died March 23, 1844; that she remains his widow; that she married him October 26, 1786. She signed this document with her mark.]


