Pension application of Allen Reade W5681 Anne f25VA Transcribed by Will Graves 6/10/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

## State of Ohio, Athens County: SS

On this 22nd day of May A.D. 1839 Personally appeared before me Ebenezer Currier one of the Associate Judges of the Court of Common Pleas in and for said County Mrs. Anne Reade, a resident of Canaan Township in the County of Athens aforesaid, aged seventy-nine years on the 19th day of January last, who being first duly sworn according to law, doth on her oath, make the following Declaration, in order to obtain the benefit of the provision made by the Act of Congress passed July 7th, 1838 entitled "An Act granting half pay and pensions to certain widows." That she is the widow of Allen Reade, who was a Private in the Army or Militia during the Revolutionary War and served as herself recollects or has been informed by himself and others, and as she verily believes, a tour of six months from August 1779 to February 1780 in a company of Militia commanded by Captain James Winn in Colonel William Washington's Regiment, that she well remembers his having been absent on said Tour for the term of six months, and understood at the time that he was in the Carolinas, that after his being at home three or four months, he enlisted for eighteen months under Captain John Ashby, and as she well recollects, was at the siege of Yorktown & taking of Cornwallis [October 19, 1781], and did not return home until about Christmas as the next year after having been absent one or two months beyond the time for which he enlisted on account of the distance they had to travel having been discharged in Georgia, where he served under General Wayne [Anthony Wayne].

She further declares that she was married to the said Allen Reade on the 28th day of February in the year 1785 that her husband the aforesaid Allen Reade died on the 26 day of January 1820; that she was not married to him prior to his leaving the service, but the marriage took place previous to the 1st day of January 1794, viz., at the time above stated.

Sworn & subscribed on the day & year above written before me, and I certify that the said Anne Reade is a credible person and further that she is unable from age & infirmity to appear in open Court.

Reade gave testimony that he is the son of Allen & Anne Reade; that he often heard his father relate his having been a soldier in the revolutionary Army; that his father died in Ross County Ohio January 26, 1820; and that the annexed lease was taken by him from the family Bible of his late Father.

State of Kentucky Nicholas County: On the 25 day of March in the year of our Lord 1839 before me Abraham Musgrove a Justice [indecipherable word or words] for said County the undersigned Dorcas Musgrove of said County and after being duly sworn according to law deposeth & saith that she to the best of her information was born about the year A.D. 1764 in Fauquier County & State of Virginia near Ashby's gap where my Father John Reed did then reside & where I did also reside until I was about 16 years old when I removed to Loudoun County Virginia where I resided until I was married which was about the year 1785. From thence I removed back to Fauquier County in said State and thence back to Loudoun County in said State where I resided until about the year A.D. 1805 thence to Bracken County Kentucky thence to Mason County in said State thence to Nicholas County in said State where I now reside. To the best of my recollection about the year 1778 or so my Brother Allen Reed [sic] then living with his Father did enter the service as a militia man in said State of Virginia and served 4 months and soon after his return he again entered the regular service for 18 months and did not return for upwards of 20 months from his departure.

State of Ohio Meigs County: On this 20th day of February A.D. 1839 before the subscriber a Justice of the Peace for the County aforesaid personally came Leticia Pilcher a resident of the County aforesaid and being duly sworn according to law deposeth and saith as follows

That she was born as she verily believes according to record on the 12th day of October in the year 1769 in Fauquier County in the State of Virginia on Little River, where her Father Philip Fishback did then reside & where he resided until I was married at the age of twenty-six in which year I with my husband Wm Pilcher removed to Hampshire [indecipherable abbreviation] State aforesaid from thence to Athens County State of Ohio from thence to Meigs County & State aforesaid where she now resides. That in the year 1779 to the best of her recollection that Allen Read then living in Fauquier County Virginia he being a half brother to my stepmother & Frequently at my Father's was drafted as a Militia man in said State of Virginia & entered the service under Captain James Minor in the Regiment commanded by Colonel William Washington in said Regiment served in the State of South Carolina I understood he was drafted for three months as a private and was kept six he left home in August and returned in February & was in the service all that time as I understood at that time and ever since without contradiction Captain Winn lived also in the same neighborhood of my Father and I knew him well. She further states she understood the last three months was voluntary service. She further states that the said Allen Read was married to Ann Fishback her own sister in her presence in her Father's house in the month of February about the year 1782 to the best of my recollection and remained his lawful wife until the time of his death which took place about the year [unintelligible] in Ross County Ohio and that she now remains his widow and is living in Athens County of Ohio. And Further this deponent saith not. Sworn to and subscribed the date above written before me S/ Leticia Pilcher, X her mark

[Veteran's widow was pensioned at the rate of \$73.33 per pound commencing March 4th, 1836 for her husband's service as a private in the Virginia service.
