[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Court of Pleas and quarter Sessions Oct. 1832

On this 17th of October 1832 personally appeared in open Court, Daniel Ball, before the Justices of the Court of Pleas and quarter Sessions for the County of Buncombe now sitting, a resident of this County of Buncombe aforesaid, aged sixty nine years, who being first duly sworn according to law, doth, on his oath, make the following declaration, in order to obtain the benefit of the Act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named officers, and served as herein stated: That he entered the service of the United States some time in the month of December 1779 being drafted in the militia in the County of Franklin N. Carolina under Captain Richard Ransom under the command of Alexander Lillington [John Alexander Lillington], Brigadier General: that he marched from thence to Charleston South Carolina where he remained until the 10th of March 1780 when he was discharged being in bad health, which discharge was signed by Genl. Alexander Lillington and is herewith

transmitted. That he entered the service again as a volunteer in the County of Franklin N. Carolina some time in the month of June or July 1780 under Captain Harrison Macon in the Regiment commanded by Col. William Brickell. That he marched into South Carolina where they Joined the Army under General Gates [Horatio Gates] and was in the Battle at Camden [Gates Defeat, August 15-16, 1780]. After that defeat the army was dispersed and this affiant went to Hillsborough in North Carolina where he obtained a furlough for a short time, and went home, that he Joined the Army again in a short time and was discharged on the 21st of October 1780 by Col. William Brickell, which discharge is herewith enclosed. That he entered the service again as a volunteer some time in the month of May 1781 in the County of Caswell N. Carolina in the Company commanded by Captain Shadrack Hargis [Shadrach Hargis]; that he marched to the town of Hillsborough where he remained where he remained until the 17th August 1781 when he was discharged, which discharge was signed by Captain Shadrack Hargis and is herewith transmitted. That he served two months afterwards under Captain Frederick Debo [Frederick Debow] by whom he was discharged at Hillsboro on the 20th of April 1782. He hereby relinquishes every claim whatever to a Pension or annuity except the present, and declares that his name is not on the Pension roll of the agency of any State.

Additional Declaration of Daniel Ball a revolutionary soldier, & resident of the County of Buncombe North Carolina

State of North Carolina Buncombe County

On the 1st Day of June 1833 personally appeared Daniel Ball before (Henry Hunt & Nehemiah Blackstock to acting Justices of the peace in & for the County aforesaid) who being first duly sworn according to law doth on his oath make the following statement in order to obtain the benefit of the act of Congress passed June the 7th 1832.

That he entered the service of the United States under the following named officers & served as herein Stated, That he entered the service of the United States about the 10th or 11th of December 1779 as a private soldier being drafted in the militia in the County of Franklin North Carolina under Captain Richard Ransom, under the command of Alexander Lillington Brigadier General, that he marched from thence to Charleston South Carolina, where he remained until the 10th of March 1780 when he was discharged by reason of his health, as it was certified by J Blyth, Surgeons, that he would not be fit for service before

the 6th of April at which time the troops was to be discharged, which Discharge was signed by Alexander Lillington Brigadier General, and is herewith enclosed having served in the aforesaid Tour just three months but did not make home until the 13th day of May 1780 by reason of sickness –

That he entered the service again as a volunteer in the County of Franklin North Carolina he believes the 10th or 11th of July 1780 under Captain Harrison Macon as a private soldier in the Regiment commanded by Colonel William Brickell, Lt. Col. of volunteers & Halifax militia that he marched to South Carolina where they joined the Army under General Gates & was in the Battle at Camden where the Army was Defeated, & most of them Dispersed, & he went to Hillsborough & obtained a furlough for a short time & went home (which was a short Distance) that he joined the Army again in a few days at Hillsboro where he was Discharged on the 21st of October 1780 by Colonel William Brickell having performed his tour of Duty which was three months & 10 days which Discharge is herewith transmitted. That he entered the service again as a volunteer in the County of Caswell North Carolina under the command of Captain Shadrach Hargis, about the 17th of May 1781 that he marched to Hillsboro North Carolina & was there stationed to guard the military stores when he was appointed a Sergeant of the company aforesaid and was discharged at that place on the 27th of August 1781 by Captain Shadrach Hargis, having served three months which Discharge is here with enclosed. That he reentered the service again as a volunteer in the County of Caswell in Captain Fred Debow's Company of Caswell Militia as orderly Sergeant in said company & marched to Hillsboro North Carolina where he was discharged by Captain F. Debow on account of peace being ratified having served two months which Discharge is dated the 20th of April 1782 & is here with transmitted, he hereby relinquishes every claim whatever to a pension or annuity except the present & declares that his name is not on the pension roll of the agency of any state.




Charles Town March 10th, 1780



[p 10: On October 4, 1845 in Buncombe County North Carolina, Ann Ball, 85, filed for a widow's pension under the 1844 act stating that she is the widow of Daniel Ball, a revolutionary war pensioner at the rate of \$40 per annum; that she married him sometime in the month of June 1788 in Granville County North Carolina; that her husband died September 29, 1844; that she remains his widow; that she prove her marriage by her original family register in the hand writing of her husband. She signed her declaration with her mark.]

[p 14: family record:

"Daniel Ball was [paper damaged and text illegible] the year of our Lord 1763 and the 17th day of August and was married the 12th day of June in the year 1788"

[p 13: Power of attorney dated August 24, 1854 filed in Buncombe County North Carolina by Hammoleketh Blackstock¹ who states she is the daughter of Daniel and Ann Ball, both deceased. In this document she authorizes her attorney to seek the increased pension due her parents based on her father's service in the revolution.

[Veteran was pensioned at the rate of \$40 per annum commencing March 4th, 1831, for service as a private & Sergeant in the North Carolina militia for 11 months. His widow was pensioned in a like amount.]
