Pension application of Thomas Entrekin W7112 Mary Entrekin f50NC/SC Transcribed by Will Graves 3/8/08 rev'd 12/10/14 & 1/13/21

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of South Carolina, Anderson District

On this 30th day of Sept. personally appeared in open court before A. P. Butler, a Judge of the Court of General Sessions and Common Pleas for the State and District aforesaid Thomas Entrekin, a resident of the State and District aforesaid, aged Seventy Four Years, who being first duly sworn according to Law, doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th, 1832. That he entered the service of the United States in the year 1776 in May of that year under Captain Robert Gillam as a volunteer for the term of six months though he served seven months against the Cherokees and Tories.

In September 1777 he served a three months tour against the Cherokee Indians under Capt. Wm Milwee [William Millwee] and commanded by Genl. Williamson [Andrew Williamson].

In May 1778 he joined Capt. Benjamin Kilgore and under the Command of Genl Williamson & Major Genl Howe marched to East Florida on an attempt to reduce St. Augustine and continued in service until the First of September after being [in the service] four months.

In October 1778 under the command of Capt. Wm Milwee he performed a tour of two months service against the Creek Indians on the Chattahoochee River under the command of Genl. Williamson.

In 1779 under the command of Capt. Charles Saxon and Genl. A. Williamson he performed a three months tour first in the lower part of the state and afterward marched against the Cherokee Indians.

In the year 1780 he served a three months tour of duty in Capt. Wm Milwee's Company in Col Robert McCreary's Regiment attached to Genl. Williamson's command in the State of Georgia below Augusta.

On the 23rd of October 1780 he joined a troop of Horsemen commanded by Col Joseph Hays [Joseph Hayes] who joined Col Thomas Sumter and was with him in the battle of Blackstocks [November 20, 1780]. He was then attached to the command of Genl. Pickens [Andrew Pickens]. During this tour he was detached under Col Wm Washington [William Washington] by Morgan [Daniel Morgan] and was with him when he defeated a body of 500 Tories and a few British Troops & Officers on the head of Bush River at Hammond's old store [December 29, 1780]. He also acted as a Pilot for Cornet Simmons and a detachment of Dragoons against the Tories commanded by Capt. Robert Cunningham. A few days after which this deponent was in the Battle of Cowpens [January 17, 1781] and remaining with the main army to guard the Prisoners until they were considered out of danger; received a

furlough to visit an Uncle near Hillsboro in North Carolina having been in active service this tour more than three months. While in North Carolina he turned out as a substitute under Count Malmody [Francis de Malmedy, Marquis of Bretagne, a Frenchman] who followed on the rear of Cornwallis near Wilmington, N.C. This service was immediately after the Battle of Guilford in March 1781 [March 15, 1781].

He returned to South Carolina and joined Capt. Wm Milwee's Company under the command of Lt Col Wm Henderson [William Henderson] and was marched to join Genl. Green [sic, Nathanael Greene] at Ninety Six with whom they continued until detached to defend the frontier settlements from the ravages of Tories and then attached to the command of Col Joseph Hayes with whom he was at the station bearing his name when they were attacked by Major Bill Cunningham of Bloody Memory and many of their numbers most inhumanly butchered on the spot.

The applicant was Born in Pennsylvania, 25th Oct. 1759 & came to 96 District in South Carolina where he was living when he entered the Service; was always a volunteer except when he substituted in North Carolina. He has given the names of officers & general circumstances as far as able; Never had a written discharge nor can he offer any other proof than that of general reputation than such as is herein furnished. He resides at present in Laurens District and makes his present application in Anderson on account of it being the residence of most of his witnesses.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the Pension Roll of the Agency of any State. Deponent has a record of his age at home from which he is certain of the year he was [born].

He was in the same company with said Entrekin during his tour which was commenced in October 1780 and agrees with him in his account of that tour. This Deponent knows of his frequent absences from home on various tours of duty and has no doubt in his own mind of the truth of his own account of his Services.

William Entrekin³ makes oath that he and his brother Thomas Entrekin lived with their father during the Revolution. This Deponent knows that he served the tour on the Florida Expedition having been with him at that time, and he believes his account of the same is correct – was not in actual service with him on any other occasions but knows that he was actively engaged and true to the cols.


