Pension application of John Stilwell (Stillwell) W7209 Jane Aspey fn68NC Transcribed by Will Graves rev'd 3/14/11

I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, I do not usually correct a transcription of a date or number which the software treats as numerals rather than words: for example, the software is set to transcript "the eight of June one thousand eighty six" as "the 8th of June 1786." I welcome and encourage folks to call errors to my attention.]

[fn p. 3] State of North Carolina, Mecklenburg County

On this 28th day of January 1844 personally appeared in Open Court Before the Court of Pleas and Quarter Sessions now sitting, John Stilwell, a resident of Mecklenburg County North Carolina aged 83 years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th, 1832. That he entered the Service of the United States under the following named officers and served as herein stated. That he was born in the County of Mecklenburg, North Carolina on the 20th of June 1861 where he lived until 1780 when he was drafted for three months and placed under the Command of Richard Springs Captain Thomas Rea Lieutenant John Baxter Ensign he then marched with his Company under the command of General Rutherford to Ramsour's Mills and assisted in guarding a number of Tories to Salisbury North Carolina where they were placed in Jail, after that he was Absent from the Army on furlough 10 days, at the Expiration of the furlough he was ordered under the Command of General Gates and marched near Rugeley's Mill in the State of South Carolina where they encamped and Slept under arms with orders to march by daylight for the purpose of reenforcing General Sumpter [sic, Thomas Sumter] at Fishing Creek above Rocky Mount in the State of South Carolina. Soon after we joined Sumter he was surprised by Tarleton's Cavalry and driven with all his forces from the State of South Carolina. That he paraded again with his Company at the Ford of Goose Creek in the County of Mecklenburg North Carolina about 20 miles South East of Charlotte by the order of General Davidson for the purpose of suppressing the Tories, there terminated the first tour of his Service. That he was drafted the second time for the term of three months and put under the command of Nathan Orr Captain the other company officers he does not remember, he marched with his Company to little Pedee River North Carolina where they joined General Rutherford and marched through the Raft Swamp and had a slight skirmish with the Tories, he then marched with his company to Elizabethtown on Cape Fear River from thence through Duplin County North Carolina to Wilmington N. C. where he remained until his last tour of service expired it being about the close of the revolution.

That he has no original discharges now in his possession not thinking they would ever be of any service to him he took no care of them and they have long since been lost or destroyed. He hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the Pension Roll of the Agency of any State.

I Wm Queery¹ of the County of Mecklenburg and State of North Carolina do hereby certify that the following detail of the services of John Stilwell during the war of the Revolution is true to my own personal knowledge – John Stilwell was living in Mecklenburg N. C. in1776 was drafted for three months in 1780 placed under the command of Richard Springs Captain Thomas Rea Lieutenant John Baxter Ensign marched towards Ramsour's Mills joined General Rutherford reached the battle ground at Ramsour's the day after the Battle assisted in guarding Tory prisoners to Salisbury Jail encamped on the banks of Yadkin River N.C., had a furlough for ten Days – again joined the Army under the command of General Gates 20 miles N. E. of Camden in South Carolina marched near Rongeys mills [sic, Rugeley's Mills?] – was sent in a detachment to reinforce General Sumter at Fishing Creek above Rocky Mount South Carolina Sumter was surprised by tarlton's [Banastre Tarleton's] cavalry Gates was defeated by Cornwallis and we were driven from the State of South Carolina &c he was then ordered by General Davisen [William Lee Davidson] to the Ford of Goose Creek Mecklenburg North Carolina to repel the Tories – he was placed under the command of Captain Oliver Wylie, Lieutenant Thomas Shelby, Ensign James M^calib and there terminated his first three months and more but he cannot recollect how much longer than three months he had to stay – he was again drafted three months in 1781 placed under the command of Captain Nathan Orr the Subalterns I do not remember he marched with his company to little Pedee River where he joined Generals Rutherford and Irwin-- marched through the Raft Swamps had some skirmishing with the Tories marched to Elizabeth town on Cape Fear River thence through Duplin County N. C. to Wilmington N. C. where he staid till his last three months tour closed

[fn p. 10: Jane A. Stilwell, 73, filed in Mecklenburg for a widow's pension on November 17, 1854, stating that she married her husband on March 18, 1805; that he died November 10, 1848. In a later filing she say she married him on March 18, 1806, married by Moses Cochran, a JP, that her name before her marriage was Jane A. Becket. Bible records in the file indicate: Jane Beckett born February 17, 1781; children of John and Jane Stilwell:
